## **Lido Beach Renourishment Project**

Alex DavisShaw, Manager for City of Sarasota, advised that

- renouishment of Lido Beach should start no later than this week, and possibly today,
- the pipe used for the project will not remain on the beach when it is not in use.
- 195 cubic yards of sand, instead of 185 cubic yards of sand, will be taken from the New Pass shoal,
- the design template has been adjusted and the sand will go all the way down to the south end of Lido, but the sand depth at the south end may be lower,
- inspectors from the engineering firm will be onsite during the renourishment,

- the long-range renourishment project will begin in September 2019.

## **Selby Botanical Gardens**

Jennifer Rominieck, CEO and President of the Selby Gardens, gave a compelling lecture with a corresponding video on the Gardens. The main points included their:

- mission statement: to provide an oasis of inspiration and tranquility, while furthering the understanding and appreciation of plants, especially epiphytes,
- vision statement: to touch as many people as possible through our urban waterfront garden that is the world leader in conservation and display of epiphytes. Visitors and volunteers alike experience the Gardens beauty, gaining a better understanding and greater appreciation of the natural world., and
- core values:

Advocacy: We champion environmental conservation and sustainable practices.

Integrity: We hold ourselves and others accountable to the highest standards of personal and professional integrity.

Financial Security: We will have the financial resources to maintain and develop the Gardens.

Stewardship: We will protect and nurture the gift of Marie Selby for future generations.

Excellence: We demand excellence in all we do.

She went on to say that they collaborate with 200 localities for research and have a Library Plan Exchange Program.

Research takes place in Belize, Cuba, Brazil, and Peru. The video was taken in Belize in 2018 and showcased their research efforts there.

She also highlighted their collaboration with Michael's on East, and how well his establishments have been received. His new 200 seat restaurant will provide a sustainable source of income, and Michael has given them a tax-deductible pledge.

Phase 1 of their construction project will begin in late-2019, and will continue for fourteen months, at a cost of \$92 million dollars, \$72 million of which is capital expenses. They have raised \$22 million to date, and this represents 40% of the cost of their first phase.

Phase 1 of the project is expected to create 1800 jobs, and when all is completed, 2800 jobs will have been created.

Responding to questions from the audience she remarked that:

- Selby is privately owned,
- no city or county funds will be used for the expansion,
- they do receive TDT grants yearly,
- they predict their earned income will double,
- a 2700 sq ft plant shop will be constructed, and
- Selby will be open during construction.

The Pool Pavilion Renovation/Expansion will go before the City Commission on January 14, 2019, at 1:30 pm at City Hall. As a note, the Planning Board denied their petition for a major conditional use change by 4-1.
