Allows caregivers to assist patients' medical use of marijuana. The Department of Health shall register and regulate centers that produce and distribute marijuana for medical purposes and shall issue identification cards to patients and caregivers. Applies only to Florida law. Does not authorize violation of federal law or any non-medical use, possession or production of marijuana.</p> <p>Increased costs from this amendment to state and local governments cannot be determined. There will be additional regulatory and enforcement activities associated with the production and sale of medical marijuana. Fees will offset at least a portion of the regulatory costs. The state revenue restricted to the purposes specified in the amendment is estimated to be \$648 million in Fiscal Year 2015-16 and grows to \$1.268 billion by the twentieth year. Whether this results in any additional state expenditures depends upon future legislative actions and cannot be determined. BEACH RENOURISHMENT/SHORELINE PROTECTION JOHN KIRKER

There have been a lot things going on the LIDO Beach SHORELINE/ RENOURISHMENT ISSUE over the past summer. I will try to recap what the status is at this time.

I want to start by explaining the Debbie (FEMA) project which is schedule to start at the end of November/December (after turtle season). A lot of the members that reside year round on Lido attended a Sarasota County Commission and staff budget workshop in June, (we had over 30 people in attendance with most speaking to our needs). One of the items discussed was the possibility of adding more sand to the Debbie project (initially 120,000 cubic yards) per the DEP permit. Alex Davis Shaw did a presentation explaining that the City was going to be allowed to add approximately another 50,000 yards of additional sand. The County agreed to find money to contribute to this extra sand. This will help in the short term, but make no mistake; this is not the long term solution to our ongoing problem.

Now on to the Army Corps of Engineers 50 year plan: When I last gave you an update regarding the status of the ACE project we were waiting on the Corps to finish up there study on the effects of dredging Big Pass. A lot negative press was going on at the time due to lack of any substantiated facts. The Corps finally completed the study (this can be reviewed on our website www.lkra.org) and it was submitted to the City and County at the end of June.

BEACH RENOURISHMENT/SHORELINE PROTECTION**CONT'D**

At the County budget meeting in July, along with talking about the Debbie project, Laird Wreford did a presentation on the ACE project report. He told the County commissioners that the report on the modeling (dredging of Big Pass) by Corps would be probably sound when the peer review was done by City and County. However, he recommended to Commissioners they do a study to determine what impact the proposed groins will have on North Siesta Key Shoreline and South Lido Park. The Commissioners agreed to discuss the project.

On July 22 the ACE did a presentation to the residents of Lido Key at the Lido Beach Resort (over 100 people attended along with the press) to discuss what their study found prior to the two public hearings scheduled for the next day (2 and 6 pm at Sarasota City Hall). Both sessions were well attended by both Lido and Siesta Key residents as well as local interested citizens. Both meetings were cordial and lots of questions/comments were taken by the Corps and everyone was told their comments would be taken back and reviewed for consideration. Once they are vetted, the Corps will come back in late September/October and there would be more public meetings on all of the input.

At the September County Commissioners meeting they authorized money for the peer review of project. I have not been contacted by the City or County as to when the next meetings will happen. Be assured, as soon as we know something, we will inform everyone as to what is going on with the project again at their September meeting.

LIDO BEACH POOL/PAVILION**CARL SHOFFSTALL**

Finally after 3 years of meetings, presentations and phone calls, an ITN (invitation to negotiate) was advertised for bids for a public/private partnership for improvements to the Pool/Pavilion. The City, with input from the Lido Key Residents Association helped craft the ITN to reflect what our members would like the final project to look like.

The ITN was released to the public the last week of August and a pre-bid meeting was held at the Pool/Pavilion on the second week of September. Several interested parties attended and had many questions for City staff as to what they will they be allowed to improve.

The ITN process allows questions to be asked by the interested parties to the City for clarification until the middle of October and then in November all bids submitted will be opened and evaluated by City staff. Once the evaluation is completed, the City will decide whether or not to move forward.

The Commissioners approved a representative from the Lido Key Residents Association to be on the evaluation committee when it convenes.

I am cautiously optimistic something good will come out of this long, long, long, process.
