Spa Shell Structure Sunbelt Hot Tubs warrants the structure of the spa against defects in materials and workmanship of the structure from date of purchase. Prorated warranty: Years 1 & 2—100%, 3—7 years—50%. Sunbelt Hot Tubs reserves the right to replace, repair and substitute any component including the shell, with one of equivalent value at our discretion.

Spa Shell Surface Sunbelt Hot Tubs warrants the acrylic finish against defects in material, workmanship, blistering, cracking and delamination for 5 years. Prorated warranty: Years 1 & 2—100%, following years 50%. Sunbelt Hot Tubs reserves the right to replace, repair and substitute any component, including the shell, with one of equivalent value at our discretion.

Spa Plumbing Sunbelt Hot Tubs warrants that the plumbing of the spa will remain free of leaks for 3 years from the date of purchase. Prorated warranty: Years 1 & 2—100%, 3rd year—50%. Warranty covers plumbing parts included air injectors, jet bodies, air hoses, PVC hoses and fittings.

Spa Equipment Sunbelt Hot Tubs warrants all mechanical and solid-state components for 3 years from the date of purchase. Pro-rated warranty: Years 1 & 2—100%, 3rd year—50%. Warranty covers any malfunction and defect in material.

Labor Sunbelt Hot Tubs warrants labor for 2 years non-prorated for authorized labor from date of purchase. The authorized service company could assess the hot tub owner for a reasonable trip charge. Visits to diagnose, inspect, or troubleshoot problems are not covered under the limited warranty.

Skirting/Cabinet Materials: Sunbelt Hot Tubs warrants the Skirting/Cabinet to be free from manufacturer's defects in material and workmanship for a period of two (2) years.

Sunbelt Installed Options: Sunbelt Hot Tubs warrants manufacturer installed options Including but not limited to; ozone, LED lighting, air blowers, stereo, speakers, wave motors, and water features to a one (1) year warranty from date of purchase.

WARRANTY LIMITATIONS

Wearable Components: Sunbelt Hot Tubs does not warrant wearable components including but not limited to, light lenses. Sunbelt Hot Tubs warrants manufacture installed limited wearable components including but not limited to jet internals to a one (1) year warranty. Sunbelt Hot Tubs warrants pillows, filter cartridges, fuses, and pump seals only up to the time of delivery. Covers & Cover Lifts are subject to the original manufacturer's warranty.

Original Purchaser & Location: Sunbelt Hot Tubs' Warranty is in effect for the Original Purchaser and at the original hot tub Installation location. Movement of the Sunbelt hot tub from the original installation location results in COMPLETE VOID of all warranty unless authorized in writing from Sunbelt Hot Tubs and preformed by a Sunbelt Hot Tubs Authorized Retailer, Distributor, or Service Agent.

Deck Ready/In Deck Spa Warranty: Hot tubs ordered without skirting or deck-ready models will have a warranty of one (1) year for all components if properly installed.

Extent of Warranty: This Warranty applies to Sunbelt Hot Tubs models manufactured and sold by Authorized Sunbelt Hot Tubs Retailers, Distributors, or Service Agents to residential retail customers and is given to the retail purchaser only. Sunbelt Hot Tubs Warranty does not extend to items, accessories or options added after factory manufacture. Cost of installation, removal and/or shipping of the hot tub are not covered by this warranty. In the event that Sunbelt Hot Tubs deems it necessary to remove the hot tub to a place of repair, or that the hot tub must be replaced, ALL costs of hot tub removal and replacement, landscaping, decking, fencing and/or structure removal, alternation and/or replacement, or any other costs of providing access to the hot tub will be the responsibility of the purchaser. This warranty applies only to a single family, residential installation. This warranty is void if the hot tub is used commercially.

Disclaimers: Sunbelt Hot Tubs or any of its authorized retailers, distributors, or service agents shall not be held liable for injury, inconvenience, loss of use, chemical or water damage, transportation cost, contingent liabilities or any other incidental or consequential cost, expenses or damages as the result of any deficiency or alleged deficiency of the hot tub. Warranty Effective: This warranty is effective for all spas manufactured after February 1, 2023.

Terms, Conditions, Limitations: In the absence of an Authorized Sunbelt Hot Tubs Retailer, the customer is to contact Sunbelt Hot Tubs directly at 1-800-258-7727 within 10 days of the onset of a problem, concern, or issue. In the case that a registered warranty card is not on file with Sunbelt Hot Tubs, it is the purchaser's obligation to provide Sunbelt Hot Tubs with a dated sales receipt to establish warranty. This warranty becomes void if the hot tub has been subjected to misuse, alteration or attempted alteration, repairs or attempted repairs by anyone other than Authorized Sunbelt Hot Tubs Retailers, Distributors, or Service Agents, or if the failure is due to improper installation, improper water chemistry, improper maintenance, an act of God, weather conditions, or other damage from cause beyond the direct control of Sunbelt Hot Tubs . Misuse and abuse shall include any operation of the hot tub other than directed in the Sunbelt Hot Tubs Owner's Manual. Examples include, but are not limited to; Damage of surface due to leaving the hot tub uncovered or due to covering the hot tub with something other than Sunbelt Hot Tubs authorized cover, damage to the surface due to contact with unapproved cleaners or solvents, damages caused by operation of water temperature outside of the approved 34F - 104F levels, damage caused by unapproved sanitizers such as calcium hypochlorite, sodium hypochlorite, "tri-chlor" type chlorine or sanitizing chemical that remain undisclosed on the spa surface, Damage due to dirty, clogged or calcified filter cartridge, Damage caused by failure to provide an even, sufficient support of the hot tub.

Warranty Performance: Purchaser must send in a completed Warranty Registration Card to Sunbelt Hot Tubs within <u>thirty (30) days</u> from the date of purchase for Warranty to be in effect. In the event of a defect notify your Authorized Dealer within <u>10 days</u> of onset. Failure to do so may result in voiding of warranty. A Sunbelt Hot Tubs Authorized technician will repair the hot tub subject to the Terms and Conditions of this warranty. Use of all reasonable means to protect the spa from further damage is expected. Reasonable travel charges may be assessed by Sunbelt Hot Tubs or technician. Reasonable charges may be assessed if sufficient access is not provided for services.

Not Covered Under Warranty: Sunbelt Hot Tubs does not warrant any damage that happens to the product itself or any of its components due to transportation, handling, moving, installation or excess of weight put on the hot tub or cover not specified or not common to the use of the product-being it made by the owner, delivery crew, transportation people, guests, or a dealer (authorized or not).
