Register with the state - <https://padohmmp.custhelp.com/app/login>

(This link will take you directly to the state website to register.)

Please note, you must have an email to register with the state. It is your responsibility to remember your login and password for future use. We can't assist with login and password retrieval. If you are attempting to be recertified and do not remember your login information, please contact the state for assistance. If you need help registering, please go to the website and watch the videos on how to register. If you are a caregiver both the patient and caregiver must be present for the appointment.

Initial Consultation In office or Telehealth - \$200.00

For convenience most visits are conducted by telehealth. For a telehealth visit you must have access to a mobile phone with audio and video capabilities. Payment will be taken over the phone prior to receiving certification. (A copy of your receipt can be picked up at the office or emailed to you upon request.) If the consultation takes place in the office payment is due at the time of the visit (no checks will be accepted). After the evaluation, the doctor will complete the certification process with the state of Pennsylvania. This includes informing the state that you have one or more of qualifying medical conditions approved by the state of Pennsylvania.

After the consultation, log back into your account with the state and pay the state fee for the Pennsylvania Medical Marijuana Patient ID card. In some instances, you may already paid the state of Pennsylvania. Your card will be mailed to the address on your drivers license, valid photo ID, change of address card. (This takes approximately 7 to 14 business days.) **YOU CANNOT USE A DIFFERENT SHIPPING ADDRESS FROM YOU RESIDENTIAL ADDRESS.**

Once you receive your card you may go to any licensed dispensary within Pennsylvania. A list of PA dispensaries can be found on the state website. The first time you visit a dispensary you will meet with the pharmacist. Many of the dispensaries have online appointment scheduling and it is recommended that you schedule your first appointment in advance.

All dispensaries require that you have your Medical Marijuana Card and your PA drivers license or photo ID with to enter the dispensary.

6-week follow up after initial certification - \$100.00 after starting the Medical Marijuana.

This is a 15-minute virtual visit with Dr. Behm. The visit is to make sure you are not experiencing negative side effects, answer any questions, discuss concerns, and answer the "substance abuse prevention" questions that will ask.

This appointment is a REQUIRED and is NOT optional.

If you fail to be present for 6-week follow up without 24 notice/cancelation:

- A phone call or a voice mail to rescheduled as soon as possible.
- You will be responsible for paying a \$50.00 NO SHOW fee, prior to being seen at rescheduled appointment.

Failure to follow requirements stated in the contract, may result in having your Medical Marijuana Card revoked, without refund.

Recertification - \$100.00 per year.

Call to schedule your recertification appointment. Download the following forms prior to recertification.

New patients call the office to register.

- New patients must complete registration forms. These forms must be received by our office prior to the visit or your appointment will be canceled. The following forms can be found on our website.
 - Patient Registration.
 - Financial agreement.
 - Medical Marijuana Contract.
 - You must review our HIPPA Privacy notice.

- Medical records or a letter from your psychiatrist/psychologist that prove you have one or more of the medical conditions must be received prior to your appointment.
- Once all completed documents are received the necessary information is obtained, we can then schedule the appointment.

Existing patients call the office to schedule.

All fees are non-refundable even if you do not meet the qualifications for certification.
