

Just What is a PMA?

PMA stands for Private Membership Association. This is a collective of individuals who choose to interact on a personal and private basis, rather than as a public forum guided by an entity, such as a corporation. A corporation is in the public, whereas a PMA is in the private.

As of the date of this writing, the PMA is growing rapidly throughout the United States. Individual professionals, such as doctors & lawyers may choose to apply the benefits of a private association, should they decide to depart from their governing bodies, and the restrictions imposed by them.
