

Paper: Microbiological History – 16 Individuals Since 1546 – Freedom From Truth

Topic: “... And ye shall know the truth and the truth shall make you free” John 8:32

This biblical quote is very familiar to most people. In many cases, including the topic of this paper, *truth* brings the decisive removal of *fear*. And most would agree that the removal of fear is a distinct characteristic of *free-dom*.

This paper honours 16 names and faces of those who stood for the truth, often at great costs to their life & position. These details are well documented for anyone wishing to perform the research. And regarding the truth in microbiology, this list is by no means conclusive.

Introduction

The most pertinent detail that has emerged since March of 2020 is that there is a significant increase in the emergence of truth on our planet. The other aspect of this detail that is even more important is that this truth emergence, in light of the circumstances of just how this planet is *organized* (manipulated), has been brought to the attention of an extremely low (but increasing) percentage of the overall population. Indeed, if one were not inclined to question their existence to any degree, THEY PROBABLY MISSED IT! This, of course, is a growing phenomenon that will only result in one final and unique conclusion (considering Earth's history).

In keeping with this truth emergence and the freedom that it definitely brings (overall), this paper is about a specific *segment* of this phenomenon – the truth of the fundamentals of (all) biology. These fundamentals were officially registered in the French Academy of Sciences in 1866 (and thereafter, many times) but the truth can be traced back, on this matter, to 1765 while the false assertion or “germs”, goes back to 1546. Here are 16 astounding individuals, since 1765, who brought forth this truth, or have had the intuitive abilities and intellectual capacity to stand with this truth, even though Earthly, mainstream “reality” does not follow these findings.

It All Started In 1546

The first notion of *infectious contagion* or “pathogenic *microbes* in the air” has been traced back to the year 1546 by a McGill University Professor of Bacteriology (F. Harrison). In his Historical Review of Microbiology he notes that Geronimo Fracastorio (an Italian poet and physician, 1483-1553) of Verona, published a work (*De Contagionibus et Contagiosis Morbis, et eorum Curatione*) in Venice in 1546 which contained the first statement of the nature of contagion, infection, or disease organisms, and of the modes of transmission of infectious disease. It should be noted that, also according to Harrison,

that the first compound microscope was not produced until 1590 in Holland. The deduction here, therefore, is that this first speculation & conclusion of *infectious contagion* was pure fantasy, or otherwise incorrect assumption.

16 Individuals Launching the Beginning of Truth Emergence on the True Fundamentals of Biology (1765):

The Chevalier Dynasty – beginning in 1765

This 4-generation Chevalier dynasty is the beginning of the recognition of inherent traits (from French genetic heritage), that can demonstrably be noted as the **ability to see**. The foundation that came from this dynasty is well noted by both the invention of the first camera and critical advancements in the area of microscopy (the achromatic lens, for example). The first optical shop, opened in 1765, by Louis Chevalier started the ball of eminence & intelligence rolling, as son, Vincent, grandson Charles and lastly great grandson Arthur completed the dynasty. It was Vincent and his son Charles (who was also trained as a physicist), who brought forth the advancements and discovery, as noted. “The first “Selon Euler” achromatic microscope was presented by Vincent Chevalier to the Academy of Sciences on March 30, 1825.” & “Charles’ creativity led to numerous optical and mechanical developments, and a vast expansion in the styles of microscopes offered.”

It is by way of this profound foundation and the training it provided that brings us to the next entry – another French countryman of the Chevalier’s...

Camille Sebastien Nachet – 1799-1881

The natural intuitive abilities of Camille Nachet was brought forth after departing from his foundational training with the Chevaliers, as he pursued his own career in microscope design & production. At the world’s fair it was Nachet, the Chevalier’s and Oberhauser who competed for the top microscope manufacturer. It was by way of one of Nachet’s microscopes (the **Nachet Compound Inverted Monocular Microscope**) that furnished the equipment necessary for the next (French) entry of truth, to see, interpret and log the details of the fundamentals of biology, to the French Academy of Sciences & Medicine...

Professor Pierre Jacques Antoine Bechamp – 1816-1908

It is noted that in the area of *microscopy* it carries with it specific dual and critical characteristics pertaining to the perception of the microscopist. They are -

1. the mechanical ability to *visually see* what is in front of them (with the proper equipment), and

2. the intellectual ability to *conceptualize & interpret* just what is before them (the proper contextual understanding),

through the lens of the microscope (see **NOTE** below). This is a factor that not only has been missed, by many, over the past 160 years or so, but also has been somewhat controlled or manipulated over this duration.

Professor Bechamp was provided with what could be considered the first equipment necessary to catch a glimpse of the fundamentals of biology. His able and dedicated colleague Professor Alfred Estor (physician & surgeon) and other support staff (including son, Joseph) were able to demonstrate their findings and register them in the latter part of the 19th century. Briefly, their discovery of the microzyma and the pertinent detail that is pleomorphism secured the basics of basic biology and opened the door to several others who repeated the findings, in the following few centuries. Pleomorphism is the ability of the microzyma to transform (morph) into various forms of other (slightly larger) microorganisms, many of which were not yet understood, during this era. The transformation to bacteria *and back again* is what was observed and discovered by Professor Antoine Bechamp. From this discovery, Bechamp noted, “Nothing is the prey of death; everything is the prey of life.” And regarding the notion of exogenous, pathogenic microorganisms as touted by L. Pasteur, Bechamp stated, **“The greatest scientific silliness of the age.”**

John Gibbs – 1811-1875

John Gibbs, his two brothers, Richard & George, and his wife were some of the individuals in the 19th century who were inspired to point out the truth, often from a simple, logical standpoint. These truths were simple deductions on the practice of “vaccination” (previously variolation in the late 1700s). While this isn’t a lucrative role to play, humanity is indebted to individuals like the Gibbs clan and the sacrifices they endured. Here are some reported characteristics of the Gibbs clan:

“Had smallpox been preventible [sic] by vaccination, such contention would have been useless... Mr. Gibbs had no difficulty in adducing evidence in proof that vaccination did not prevent smallpox.”

“With many illustrations from medical literature, Mr. Gibbs enforced a lesson that diseases were not irregular and detached disasters, but varied manifestations of a common disorder: that when one form prevailed, other forms abated or disappeared; that health, and the defect of health, were referable to habits and conditions of life...” [Truth has company, as one would suspect – nurse Florence Nightingale concurred on this topic and was also outspoken on matters of truth.]

“Gibbs [b. 25th May, 1811]: “How absurd to pretend to the possession of a prophylactic of such unquestionable potency that its acceptance requires the threat of force!...””

“Miss Griffiths soon learnt that three relatives — John, Richard, and George Gibbs — had for twenty years been writing and working against vaccination, besides Dr. Collins and others.”

Mrs. Gibbs (d. 10th November, 1878) – Formed the Mother’s Anti-Compulsory Vaccination League. [Important to note here is the reason Mrs. Gibbs was urged to formulate this group is due to the fact that despondent mothers had nowhere to turn when compulsory vaccination (a political event) became a thing, and after losing one child to the vax, were unable to stop the occurrence from repeating itself. It may be a relief, for many to know, that this and all other forms of corruptive practices will soon be over, for this planet.]

James John Garth Wilkinson (physician) - 1812-1899

Dr. Garth Wilkinson was alerted to vaccine damage, part way through his practice, and this is a synopsis of his testimony:

“The early history... I had not considered Vaccination a question; but practised it when required... Vaccination is an infinitesimal affair...” Follow up: “After-studies extending over 18 years have convinced me that I was wrong in my estimate of the smallness of the Vaccination question compared with other Evils. As forced upon every British Cradle, I see it as a Monster instead of a Poisonous Midge; a Devourer of Nations. As a Destroyer of the Honesty and Humanity of Medicine, which is through it a deeply-degraded Profession. As a Tyrant which is the Parent of a brood of Tyrants, and through Pasteur and his like a Universal Pollution Master. As a Ghoul which sits upon Parliament, and enforces Contamination by Law, and prepares the way for endless violations of personal liberty and sound sense at the bidding of cruel experts. Not denying other forms of Social Wickedness, I now, after careful study, regard Vaccination as one of the greatest and deepest forms, abolishing the last hope and resort of races, the new-born soundness of the Human Body.” [It is worth noting that Dr. Wilkinson’s work and testimonial evidence, along with a vast body of other evidence, had to be intentionally suppressed in order for an alternative system to flourish and profit.]

Florence Nightingale – 1820-1910

Most people know Florence Nightingale as *the mother of modern nursing*. This virtuous description of her goes beyond what one may think of as standard nursing practices. “She excelled in mathematics and languages and could read and write French, German, Italian, Greek, and Latin at an early age. Never satisfied with the traditional female skills of home management, she preferred to read the great philosophers and to engage in serious political and social discourse with her father.” Her keen intuition led her to observe that there was no such thing as *disease*, but rather the human being was subject to varying responses to the environment, causing *dis-ease*. She observed what was claimed to be *typhus* changing into another claim of *smallpox*. She also intuitively confirmed Antoine Bechamp’s findings when she would go into a patient’s room, open the drapes and windows, thereby creating the influence of *normal air* [Prof. Bechamp never found pathogenic microorganisms in *normal air* – this

finding was not for lack of ability as he was able to discover the fundamental microorganism of all biology that eluded all but a few of his contemporaries - ~50 to 150 nm.].

Montague Richard Levenson – 1830-1925

Montague Levenson, a homeopathic physician, rancher, lawyer and politician, emigrated to the U.S.. Upon learning of the findings of Antoine Bechamp he travelled back to the UK around 1900 to interview the professor. His translation of documents were and are pertinent to the understanding of the foundation of microbiology, as the truth was first discovered. In spite of *ad hominem* attacks, Levenson's contributions are well noted.

Gunther Enderlein – 1872-1968

Gunther Enderlein was a professor, physician and researcher who became another re-discoverer of the fundamental particle of biology and of the process adherent to this microorganism, pleomorphism. His career and depth of research was long and detailed. His published works were in German, which remains to be a common roadblock to truth in many cases.

NOTE: The next 3 entries on this list had the mechanical ability, by way of the Rife Universal Microscope, to properly view live blood. However, the doctrines of standardized (Pasteurian) medicine of the time were enough to cloud the viewpoints of these individuals to where a clear understanding (essential point #2 – contextual understanding) was not fully grasped. Quotes by E. Rosenow and R. Rife (below), however, tell us that fundamentally they knew a good deal of truth in microbiology, nonetheless.

Edward Carl Rosenow - 1875-1966

E.C. Rosenow was a trained physician who rubbed shoulders with A. Kendall in Royal Rife's laboratory. Both Rosenow and Kendall were *filtrationists* as opposed to *non-filtrationists*. The filtrationists went against the standard viewpoints of the medical establishment in that they knew that there were sub particles that were so small that they could be separated by filtration from the rest of the components of the blood. This primary admission is the first step in the realization of the fundamental particle of all biology: the microzyma. However, as mentioned, it is sometimes demonstrably tough for some who are trained in the Rockefeller drug ideology establishment to view samples outside of the pathogenic principle.

Arthur Isaac Kendall – 1877-1959

Arthur Kendall was also a prominent trained physician and part of the research team with Rosenow and Rife.

Royal Raymond Rife – 1888-1971

Roy Rife is one of at least 3 geniuses in the field of vision in that he built his own microscope consisting of 5,682 parts (the Universal Microscope) which was capable of up to a 60,000x magnification of live blood samples. It is the ability to view live blood with live microorganisms that has become the anomaly and one of the other roadblocks to bring forth the truth of microbiology. There are contrary elements to the Rife story, however, in that there are two different realizations coming from his lifetime of discoveries. They are:

1. He seemed to have been caught up in the *germ theory* notion of microbiology in that he became somewhat of a P.B.H. (Pasteurian Bug Hunter). In this area of his work he claims to have located the microorganism that *caused* cancer, developing a frequency generator dialed into a particular level to eliminate the *microbe*. In this way, given the 2nd realization following, Rife's success in alleviating the symptom known as *cancer*, may have followed the general trend of Gaston Naessens discovery of 714-X, which also gave the body a fighting chance to eliminate the so-called *disease, by its own merits*.
2. With the profound ability to view live blood, the fundamentals of microbiology were at Rife's door. How it is that he missed the boat on what his predecessors had discovered, with less equipment, remains a mystery (see the dual characteristics of microscopy, above). The pertinent details on this matter, however, are, that *filtrationist* fellow researchers collaborated heavily with Rife. They are Dr. E.C. Rosenow and Dr. Arthur Kendall. [The filtrationist's findings were that there were elementary microorganisms smaller than bacteria that could be filtered out of the blood. This understanding aligns with the microzyma and went against orthodox medical research (the germ theory of understanding), for obvious reasons. *Filtrationists* generally, and Rife specifically, were persecuted in the political/legal spheres, common to others on this list.]

Further to this, here is a **quote** directly from Dr. Rife which sets the record straight on his *contrary* realizations -

“In reality, it is not the bacteria themselves that produce the disease, but the chemical constituents of these microorganisms enacting upon the **unbalanced cell metabolism** of the human body that in actuality produce the disease. We also believe if the metabolism of the human body is perfectly balanced or poised, it is susceptible to no disease.” [Here we have the admission of truth – the *unbalanced cell metabolism* being the cause of disease – which, of course, is *toxicity & care for the terrain*.]

Wilhelm Reich – 1897-1957

The persecution of alternative views is a common thread during the past century and a half since the false notion of *germ theory* was given its largest boost. Wilhelm Reich, a Viennese trained psychiatrist, went on to re-discover the fundamental particle of microbiology among other things that brought down the wrath of the Rockefeller medical complex upon him. His legacy is well documented including his death in a federal prison at 60 years of age.

Gaston Naessens – 1924-2018

Gaston Naessens, also a re-discoverer of the elementary particle in biology is the third (astounding) microscope builder on this list, and the second one to produce a microscope with a 60,000x magnification, used in the inspection of live blood. He also exemplifies the *second* characteristic of a microscopist in that he defined a 3-stage micro-cycle, a 13-stage macro-cycle (giving 16 individual stages of pleomorphic activity) from this fundamental microorganism. In this regard, and from what is commonly available on the topic, Gaston Naessens stands as unique, along with his countryman, Antoine Bechamp, in this realm of truth (although similar findings came from places like Germany, during these times). Mr. Naessens also stands as a prime example of alternative view persecution from the political/legal system. And part of Naessen's difficulty in expressing the truth on this matter, like Enderlein, was his lack of familiarity of the English language.

It is worth noting that the two books written by Christopher Bird on the research of Gaston Naessens have almost been completely eliminated from public availability as of the date of this paper. This phenomenon has been systematically occurring since March 2020.

Philippa Uwins

This researcher from the University of Queensland appears to be the latest re-discoverer of the fundamental microorganism, in 1998. She also seems to be the only one who is living which is why it seems there is not much information about this re-discovery (especially when given the treatment of her predecessors).

Of Note

It may be important to also record this admission from the New York Academy of Sciences, for this topic (dated 30 Oct. 1970):

“Microorganisms or various sorts have been observed and isolated from animal and human tumors, including viruses, bacteria and fungi. There is, however, one specific type of highly pleomorphic microorganism that has been observed and isolated

consistently by us from human to animal malignancies of every obtainable variety for the past 20 years... The organism has remained an unclassified mystery, due in part to its remarkable pleomorphism and its stimulation of other microorganisms. Its various phases may resemble viruses, micrococci, diphtheroids, bacilli and fungi.”

Of course, it is noted, that anything can become an “unclassified mystery” if you ignore the research that actually classified the “mystery” (the French Academy of Sciences & Medicine). It is noted that this declaration has been available, and largely ignored, for 60 years now (as of 2026).

Conclusion

The impetus & drive to seek a logical foundation to what occurred commencing March of 2020 was a necessary affair. This is the action to lock down society because of a supposedly deadly pathogen floating around in free air, across the globe. Historically, as a different “pathogen” with a different acronym attached to it accompanied by a different CGI image was displayed, on the cover of Time magazine, every other year, for the past 3 decades or so, the possibility of western civilization media programming, **also** became a real possibility. This is all it took to dig into the **real** truth behind this continuous fear campaign that is this barrage of infectious, exogenous, pathogenic “microbes” (microbe being an invented word to fit a false theory ~1865). As has always been the case (in my lifetime), the truth is readily available... but one must seek it (amongst the media programming and big science propaganda).

Seeking truth is really not all that difficult. While there are several methods or check systems that can go into finding truth from falsehood, the largest and simplest one is the ***test of potential or realized profit***. In this case one must simply address this question, “What does each side have to gain by their position on the matter?” The level of difference between these two answers is linearly & inversely proportional to the relationship of truth, between the two sides, in many cases. There is nothing wrong with being profitable and money is not the cause of evil, but when the average person suffers at the hands of a profit-maker, to ludicrous & dangerous proportions, the game gets serious.

We are there now.

Truth is emerging in record proportions.

The dawning of a new Earth follows this global awakening.
