# FOR ALL CIVIL TRAFFIC OFFENSES YOU MAY (CHOOSE ONE OPTION ONLY):

- 1. Pay the fine by mail or in person. You can appear or pay the fine on or before the due date. Feel free to call the court if a payment plan is needed.
- 2. Request a hearing (trial) by mail or in person. By following the instructions in Option 2. The hearing must be requested on or before the due date shown at the bottom of your citation.
- **3.** Attend a Defensive Driving School if you are eligible. For more information, read Option 3 contained on this insert

Failure to Appear and/or pay fine by appearance date on a civil traffic complaint will result in a Default Judgement entered against you. The fine will be imposed along with a \$20.00 time payment fee, a \$75.00 Default fee per Ordinance #2022-01 and collection fees will be added to the civil fine amount imposed. The Default will also be reported to the Arizona Motor Vehicle Department.

<u>Failure to Appear for a Misdemeanor Violation</u> will result in a Failure to Appear warrant.

# Option 1 Paying your fine by mail by entering a plea of RESPONSIBLE (Civil Traffic Offenses ONLY)

You may pay for your traffic violation(s) online or by mail if the violation amount is shown on the Fine/Sanction Schedule section of this form. If the violation is not listed on the schedule, you must call the court to get the correct Sanction amount. This must be done on or before the **APPEARANCE DATE**.
