Eagle Scout Project Presentation – Jaxon Morehouse Troop 381, located in Wheatland Wisconsin is working toward earning his Eagle Scout rank and has proposed installing a fence around Holy Communion Cemetery on White Pigeon Rd as his Eagle Scout project. Each year, his Troop honors veterans by placing flags on 36 memorials at the cemetery on Veteran's Day. Before Jaxon can begin his Eagle Scout project application, he needs approval from the beneficiary, which he initially believed was the Village. Attorney Schuk noted that the Village may not own the cemetery, but the Village Clerk can assist in determining ownership and inform Jaxon accordingly. Robbie Robinson from SWRPC presented the proposed amendment to the Sewer Service Area (SSA). The Village reached out in 2024 to add the Pell Lake Drive area and later added a possible development on Daisy Dr. The amendment would add Pell Lake Drive area and a potential development area on Daisy Drive to the existing SSA. The amendment is needed to allow future sewer service extensions to these areas, including proposed mixed-use development along Pell Lake Dr/Hwy 12 and residential development on Daisy Dr. Robinson explained that state regulations require properties to be included within the SSA before sewer extensions can occur.

The SSA was originally established in 1996 and amended in 2003. The primary purpose of the current amendment is to add the two new areas to the existing service area.

In response to questions, it was clarified that existing property owners within the proposed amendment area would not be required to connect to sewer service solely because their property is added to the SSA. The amendment would make sewer services available if needed in the future.

President Aronson asked 3 times if anyone wanted to speak against the amendment:

Linda Sue Moran N1220 Cty Rd H - asked whether there would be a cost to Village residents or whether developers would pay impact fees, Attorney Schuk stated that developers would be responsible for costs associated with their developments.

Both Trustee Conlon and Trustee Marcinkus expressed support for the proposed SSA extension.

She also noted that there are conflicting setback requirements in the ordinance where chickens are concerned.
