TAX COLLECTION INFORMATION

Bloomfield Collection Hours: Monday through Thursday 10am-4pm
TAX OFFICE CLOSED ON DEC 24, 25, & 31 and JAN 1 FOR THE HOLIDAYS

There is a drop box located in front of the Town Hall. Tax Payments deposited in the drop box will be processed during normal business hours.

1st installment or full amount due January 31, 2025.

Pay Tax Bills via Check

- Please use a separate check for Dog Licenses. If you would like a receipt, please include a selfaddressed, stamped envelope <u>SEPARATE FROM YOUR</u> <u>TAX RECEIPT ENVELOPE.</u>

Pay Tax Bills via Cash

- Cash payments must be in EXACT dollars and cents.
- Can be made in-person at N1100 Town Hall Rd Pell Lake, WI 53157.

Overpayments over \$5.00 will be refunded within 14 days of the processing date.

Did you get the lottery credit on your tax bill?

To qualify for the Lottery and Gaming Credit, you must be a Wisconsin resident and own a dwelling that is your primary residence as of January 1st of the year the property taxes are levied. You may only claim one primary residence. You may not claim the credit on business property, rental units, vacant land, garages, or other property that is not the owner's primary residence. GARBAGE/RECYCLE DISPOSAL

WINTER PARKING: Ordinance 7.05

- 1. No person shall park, stop, or leave standing any vehicle on any street between 2am and 6am from November 15th of each year to April 15th of the following year.
- 2. No person shall park, stop, or leave standing any vehicle, except an emergency vehicle, on or within five (5) feet of any street or public way after a two (2) inch snowfall. There is hereby declared to exist an emergency to exist in Bloomfield by reason of heavy snowstorm whenever snow falls during any period of twenty-four (24) hours or less to a depth of two (2) inches or more OR icy conditions in that such storm constitutes a serious public hazard impairing transportation, the movement of food and fuel supplies, medical care, fire, health, police protection, snow removal equipment or other vital facilities of the municipality. Such emergency is declared to continue until such time as snow-plowing operations have been declared completed.

VIOLATIONS OF THESE RESTRICTIONS MAY RESULT IN A CITATION BEING ISSUED, THE VEHICLE BEING TOWED AT THE OWNER'S EXPENSE, OR BOTH.

DOG LICENSES

Municipal dog licenses are required in Bloomfield in addition to the rabies tag issued by your veterinarian. State law requires that all dogs be vaccinated against rabies within 30 days of reaching five months of age and that future protection be kept current. Please provide proof of vaccination, a completed form (can be found at www.villageofbloomfield.com or at the Town Hall) and the appropriate fee(s). Spayed/Neutered dogs are \$16 each. Unaltered dogs are \$35 each. Maximum number of dog and cat combinations is three (3) per household. Please write one check payable to the Bloomfield Treasurer. This check MUST BE SEPARATE from your tax bill check.
