There is a drop box located in front of the Town Hall. Tax Payments deposited in the drop box will be processed during normal business hours. If you would like a receipt, please include a self-addressed, stamped envelope.

1<sup>st</sup> installment or full amount due January 31, 2024.

Bloomfield Treasurer. Please refer to the website if you are unsure
which municipality you reside in.

2<sup>nd</sup> installment due July 31, 2024.

Payable to the Walworth County Treasurer.

### Pay Tax Bills Online

- We accept Visa, MC, and Discover as well as an e-Check.

- Convenience Fees are \$1.10 for a check/savings account and 3% for credit/debit or \$0.50 if under \$100.

#### Pay Tax Bills via Check

- "Village" Tax Payments must be on a <u>SEPARATE CHECK</u> from "Town" Tax Payments.
- Can be dropped off in person to N1100 Town Hall Road or mailed to PO Box 609 (Village) or PO Box 704 (Town), Pell Lake, WI 53157.
- Escrow checks must be endorsed on the back of the check.
- If left in the drop box, please enclose a self-addressed, stamped envelope and we will mail you a receipt.
- Please use a separate check for your Dog License. If leaving in the drop box and you would like a receipt, please include a selfaddressed, stamped envelope SEPARATE FROM YOUR TAX RECEIPT ENVELOPE.

#### Pay Tax Bills via Cash

- Cash payments must be in **EXACT** dollars and cents.
- Can be dropped off in person to N1100 Town Hall Road, Pell Lake, WI 53157.
- If left in the drop box, please enclose a self-addressed, stamped envelope and we will mail you a receipt.

Overpayments over \$5.00 will be refunded within 14 days of the processing date.

Did you get the lottery credit on your tax bill?

To qualify for the Lottery and Gaming Credit, you must be a Wisconsin resident and own a dwelling that is your primary residence as of January 1<sup>st</sup> of the year the property taxes are levied. You may only claim one primary residence. You may not claim the credit on business property, rental units, vacant land, garages, or other property that is not the owner's primary residence. #### GARBAGE/RECYCLE DISPOSAL

The Town & Village of Bloomfield began a contract with Johns Disposal Service for curbside collection, effective 1/1/23. #### WINTER PARKING: Ordinance 7.05

- 1. No person shall park, stop, or leave standing any vehicle on any street between 2am and 6am from November 15<sup>th</sup> of each year to April 15<sup>th</sup> of the following year.
- 2. No person shall park, stop, or leave standing any vehicle, except an emergency vehicle, on or within five (5) feet of any street or public way after a two (2) inch snowfall. There is hereby declared to exist an emergency to exist in the Village and Town of Bloomfield by reason of heavy snowstorm whenever snow falls during any period of twenty-four (24) hours or less to a depth of two (2) inches or more OR icy conditions in that such storm constitutes a serious public hazard impairing transportation, the movement of food and fuel supplies, medical care, fire, health, police protection, snow removal equipment or other vital facilities of the municipality. Such emergency is declared to continue until such time as snow-plowing operations have been declared completed.

VIOLATIONS OF THESE RESTRICTIONS MAY RESULT IN A CITATION BEING ISSUED, THE VEHICLE BEING TOWED AT THE OWNER'S EXPENSE, OR BOTH.

#### **DOG LICENSES**

Municipal dog licenses are required in Bloomfield in addition to the rabies tag issued by your veterinarian. State law requires that all dogs be vaccinated against rabies within 30 days of reaching five months of age and that future protection be kept current. Please provide proof of vaccination, a completed form (can be found at <a href="https://www.villageofbloomfield.com">www.villageofbloomfield.com</a> or at the Town Hall) and the appropriate fee(s). Spayed/Neutered dogs are \$16 each. Unaltered dogs are \$35 each. Maximum number of dog and cat combinations is three (3) per household. Please write one check payable to the Bloomfield Treasurer. This check MUST BE SEPARATE from your tax bill check.
