Sealed bids, for the Village of Bloomfield “**N. Bloomfield and Lyons Road Paving Program**” Contract, will be received by the **Village of Bloomfield**, until **Thursday, June 4th, 2026, at 9:00 a.m., CDT**. This project is partially funded by **Local Road Improvement Program (LRIP)**

The Base Bid work for the above contract includes the following roadways:

- N Bloomfield Road (North Rd to Cortona Ln)
 - o 9000 LF of 2” mill and overlay of 2.25” and shouldering, included in that a 1500 LF section of full depth removal with base work.
- Lyons Rd (N. Bloomfield Rd to County Line)
 - o Asphalt overlay and shouldering.

Major Base Bid Items of work with approximate quantities for which bids are requested, include: **4,535 TON** of HMA Pavement, **22,000 SY** of Asphalt milling, **1,833 CY** of Excavation Common (EBS) and **700 TON** of ¾” Base Aggregate Dense for shouldering. Items also included in this project are preparing asphalt butt joint, and traffic control.

The Bidding Documents, consisting of Advertisement for Bids, Instructions to Bidders, General Conditions, Supplementary Conditions, Bid Bond, Agreement, and Specifications, may be examined at questCDN.com by inputting Quest project #**10207244** on the website’s Project Search page.

A Bidders qualification statement form will be issued with the Bid Documents. The Bidders Qualification Statement form must be completed and submitted in a sealed envelope at the time of Bid submittal. No bids will be accepted from any Bidder who has not submitted the Bidders Qualification Statement form. Contractors who have submitted prequalification statements to the Village of Bloomfield shall state this on their Bidders Qualification Statement form and prequalification forms will be reviewed. The Owner reserves the right to reject the bid of any Bidder who has been determined to be unqualified.

As a part of their Bids, Bidders shall submit a full and complete list of: 1) all of the proposed Subcontractors, and 2) the class of work which each will perform. The selected Contractor shall not alter this list without the written consent of the Village.

The PS & CD require that the selected Contractor and Subcontractor(s) furnish a Certificate of Insurance.

Bidders shall submit Bids online through QuestCDN.com. Bidders should pay attention to the requirements for Bid signatures, as set forth in Bid Security. Bidders may not withdraw their Bids within the 90-day period after the date of the Bid Opening

The Village will only consider Bids from Bidders who accompany them with a Bid Bond, payable to the Village of Bloomfield, in the amount equal to 5 percent of the Bid. This requirement serves to guarantee that, if the Village accepts the Bid, the selected Contractor will execute and deliver the proper Contract Agreements and Bonds within 15 calendar days after the Notice of Award.
