1. Acceptance of Terms

By booking or using ASMR&YOU services, you agree to these Terms of Service.

2. 18+ Requirement

By using this platform, you confirm that:

3. Nature of Services

4. Model Representation & Profiles

Models operate under stage names and curated personas.

Public profiles may include:

- Real photographs
- Stylized or aesthetic images
- Thematic or mood-based imagery

Users acknowledge that profiles are curated representations for entertainment and branding purposes.

ASMR&YOU does not guarantee real-time appearance, location, or personal details.

5. Platform Usage

Sessions may occur through approved third-party applications such as:

- Signal
- Telegram

Users are responsible for installing and maintaining required applications.

ASMR&YOU is not responsible for service interruptions caused by third-party platforms.

6. Payments

All sessions must be paid in advance.

Prices are displayed at booking.

ASMR&YOU reserves the right to modify pricing at any time.
