Entries open October 9th at **12:00 PM** (MST), early entries **cannot** be accommodated. NO drop off entries in the main mailbox by the street, it's illegal and they will be shredded.

Drop off entries **ONLY** in the box affixed beside the garage door. Do Not place on front porch, Do Not knock-on door, Do Not ring doorbell. Do Not enter property before 12:00PM. If multiple exhibitors are present; observe appropriate distancing, Thank You so much!

ENTRIES CLOSE Wednesday, November 16th, **12:00 PM** (MST) OR WHEN LIMITS HAVE BEEN REACHED at the address of the Trial Secretary, after which time entries cannot be accepted, canceled, or changed, except for as provided in Chapter 1, Section 16 of the AKC Obedience Regulations. All entries, including wait listed entries, must

be received by the trial secretary prior to November 16th, 12:00 PM.

Bitches in season: A written request (email notification is acceptable with return email receipt verification from the secretary) is required to receive a full refund and the request must be received by the Trial Secretary no later than 24 hours prior to the start of judging.

Entries will be refunded if the show is canceled due to COVID 19.

Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3).

Dogs listed in the AKC Canine PartnersSM Program should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

A recording fee of 50 cents per first entry of each dog and Event Service Fee of \$3.00 per entry is required for each dog entered at any Licensed or Member Club Show or Obedience Trial. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the recording fee is to be collected on the first entry only Ch. 11, Section 2, AKC Dog Show Rules.



-The club assumes no responsibility for a wrong entry. -Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted. -The owner is responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. No dog wrongly entered in a class may be transferred to another class after close of entries. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable. -Entries will receive an email confirmation within 7 days after receipt, if an email address is provided on the entry form, otherwise, the confirmation will be sent via USPS standard mail. If acknowledgments are not received by an exhibitor 7 days prior to the Trial, please notify the Trial Secretary. -Consult Judging Schedule for time of judging. -Exhibitors and handlers alone are responsible for the presence of their dogs in the judging ring. -The Club and the Trial Secretary assume no

responsibility in this regard. -The Club will exercise every precaution for the safety of dogs exhibited, but it must be understood that the Club will not be responsible for loss or injury. -Dogs must be kept on leash except when in the judging ring. -There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises. -In case of a tie for any prizes, any dog that is not present for a run-off forfeits the right to the prize. -Entry fees will not be refunded in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, loss of site, or other acts beyond the control of the Club, or if it is impossible to open or to complete the Trial, no refund of entry fees will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat, or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the Trial before completion, no refund of entry fees will be made.

- MOVE-UPS (Class Transfers) will be permitted in accordance with Chapter 1, Section 16 of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, but at least 30 min. prior to the start of the days judging.

-BITCHES IN SEASON are not permitted to compete. If a female is withdrawn from competition for coming into

season and the Trial Secretary is notified no later than 24 hours prior to the start of the first class, then the Club will refund the entry fee, less a \$10 processing fee, unless the spot can be filled by someone on the waitlist.

Rules for entering this trial:

1. **NO Glass containers allowed on property/grounds.**
2. NO smoking/vaping allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. Collars must be in accordance with AKC Board Policy, July 2001 (No Electronic Collars)
5. There shall be no drilling, intensive or corrective training of dogs on Trial grounds or premises
6. Crating: Outdoors on grass. Pop-ups allowed. Wire/metal crates are encouraged for safety and ventilation. Mesh crate must be completely zipped closed while dog is inside.
7. Dogs that escape from crate or are uncontrolled must be removed from the show site.
8. Please keep dogs quiet, if barking cannot be controlled, you will be asked to leave. Keep dogs on leash while not exhibiting.
9. **EXHIBITORS RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS.** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Disposal sites will be available at various locations around the show grounds.
10. RVs allowed in daily parking, overnight. (see RV Parking form) page 11.

"Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."



Gambel Field do's and don'ts

Sorry!!!! No glass containers on property, not even Dr Seuss

- 1) **NO GLASS**—We don't care what's in the container only that the container itself is not glass.
- 2) Do not drive on/park on the grass. The edge markers (white buckets) are your guide, don't move them, squeeze between them, or otherwise try to manipulate the rule. Event set up personnel/vehicles must check in with Jane.
- 3) Campfires – Allowed only on sand/dirt areas, NEVER on the grass. If it is windy, don't light a fire. If there is a County or State Burn Restriction in place, don't light a fire. You must be able to control or extinguish your fire at all times.
- 4) Do not touch the irrigation pipe covers. Don't climb on, sit on, kick, wiggle, or lean against the irrigation pipes and or coverings. Damaged irrigation pipes = no water for your event. If I must fix any of the pipes due to damage by guests, your event will be responsible for repair costs and your event's deposit will be forfeited.
- 5) Clean up after yourselves and your pets.
- 6) Noise carries out here at night. Please be courteous to each other and the community neighbors with your volume.
- 7) The raised area on the west side of the property, where the buildings are, is **STRICTLY OFF LIMITS**. This area is our private residence/homesite.
- 8) Dust is best controlled by controlling traffic speed. Be aware you are driving on dirt/sand. The faster you drive the more dust you have. **SLOW DOWN**.
- 9) Coyotes – yes you may hear or see them in the area. Please protect yourselves, your pets, and your food storage.
- 10) If you have any questions or concerns, contact Show Chair. Failure to abide by these rules can result in the forfeiture of the event's security deposit, personal damage charges, removal of offending persons from the property and, in extreme cases, cancellation of the event.



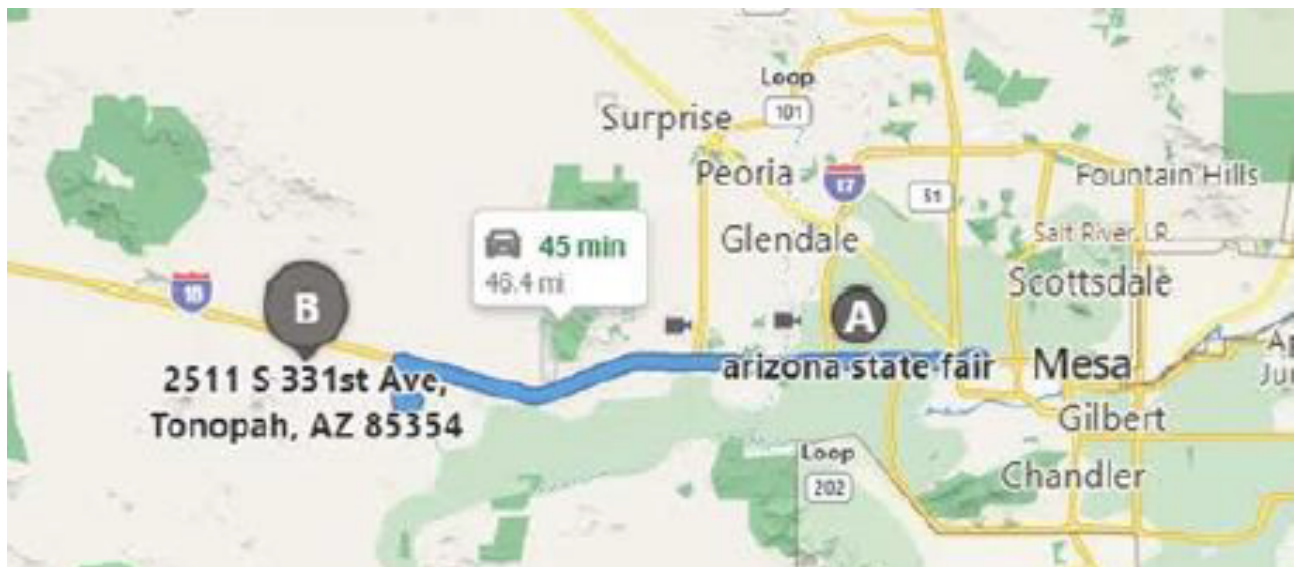

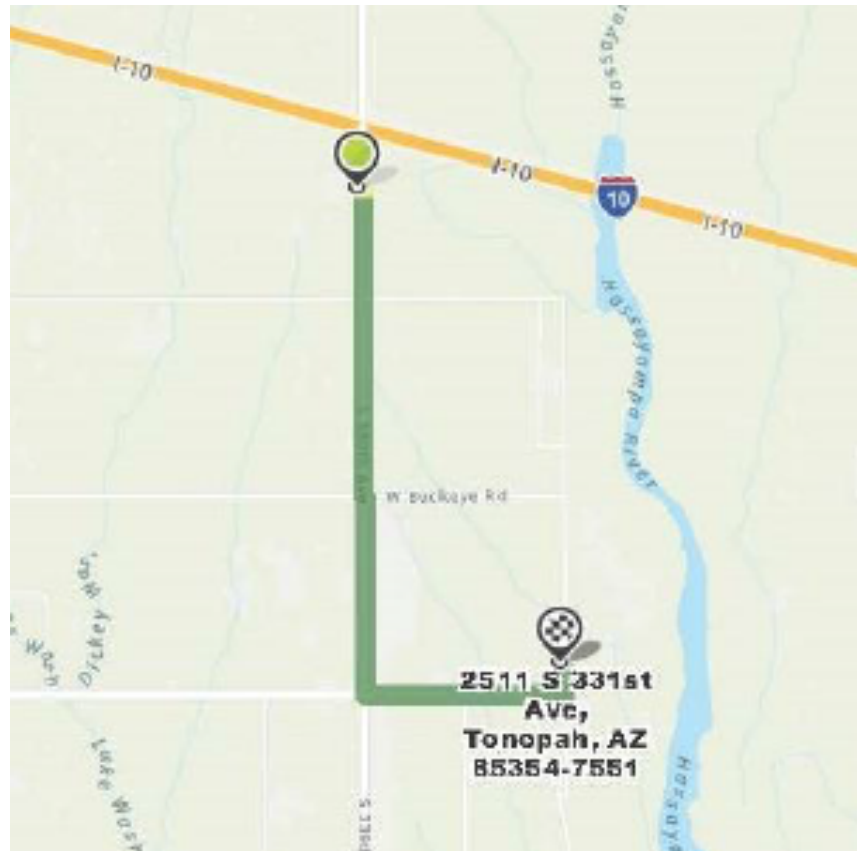

LOADING/UNLOADING ZONE: This zone will have a 15-minute limit and is available during show hours. You may take your dogs and equipment to your setup, but please return and move your vehicle to a designated parking area.

The American Kennel Club Temperament Test:

The purpose of the ATT is to test for fear, shyness, inability to recover, and lack of cooperation. The AKC Temperament Test (ATT) is a general temperament test for all breeds and mixed breed dogs assesses a dog's reaction to a variety of stimuli. These stimuli are in the following six categories: Social, Auditory, Visual, Tactile (touch), Proprioceptive (motion) and Unexpected Stimuli. Desired traits are; emotionally stable, inquisitive, appropriately social for its breed, biddable, and demonstrates the ability, to recover from a startling situation, in a reasonable amount of time. Dogs who show signs of aggression will not pass the test. One purpose of the ATT is to educate dog owners about the temperament of their breeds. At each test, in addition to a title application form and their contact information on the evaluator's checklist, handlers complete the form labeled, "Your Breed's Temperament." The form includes a space for the handlers of mixed breed dogs to write about the temperament of their individual dogs. Our Club is required to print the Breed Temperament Guide (www.akc.org/akctemptest) and have copies on the registration table and/or a poster. TEST INFO: The ATT is a non-competitive pass-fail test. In a test, a dog must pass 3 test items in each of the six categories (total of 18 test items). These are selected from a list of 24 possible test items. All dogs who pass the ATT twice under two different approved ATT Evaluators may earn the AKC Temperament Test (ATT) Title.

Please Bring Your Own Props!!

There are five AKC Trick Dog Titles you and your dog can earn:

- AKC Novice Trick Dog (TKN)- Your dog performs 10 skills from the Novice list. If a dog has a Canine Good Citizen (CGC) certificate or title on record at AKC, it can do 5 Novice tricks (CGC + 5) to earn the Novice title.
