Service Contract Part Two: Hair and Makeup Services/Schedule/Providers

1. Bridal Bliss (BB) Hair and Makeup Artists (artists) will provide hair styling and makeup supplies. This includes, but is not limited to, hair pins and bobby pins, curling and flat irons, hairspray, and makeup supplies, including but not limited to: foundation, blush, eye shadow, mascara, eye and lip liner, and lip stick. Airbrush makeup and false lashes can also be provided.
2. BB artists are not responsible for providing: hair accessories, such as decorative hair pins, tiaras, veils, etc.
3. In order for BB to travel for hair services there is a minimum of \$500 in hair services. In order for BB to travel for makeup services there is a minimum of \$300 in makeup services.
4. BB will provide the client with a schedule of services, including a start and end time based on the completion time stated above. The start and end times must be adhered to, by both the client(s) and the artists of BB. Overtime charges begin if your party goes beyond the allotted time, with an overtime rate of \$30 per half hour or \$60 per hour, per stylist, assistant, and makeup artist. To avoid overtime charges, notice should be given to all clients receiving hair and/or makeup services to arrive on time for their appointments. While BB will do what they can to accommodate late arriving clients, it may not always be possible to provide the services.

- 5. It is best not to wash your hair the day of the service. It is preferred to have the hair washed 1 day before. Exception: flat ironed hair cannot be curled. If you have flat ironed since your last wash and intend for the artist to curl your hair, you will need to rewash your hair and style without flat ironing before the service. **Your hair should not be wet** when the artist arrives, BB does not bring blow-dryers and do not provide blowout services. Notice should be given to everyone in your party that is getting hair services about the washing and flat ironing guidelines, everyone receiving hair services should have clean, dry hair.
- 6. Your face should be freshly washed, moisturized and free of all makeup when the artist arrives. Doing your normal face care routine is recommended. Notice of this should be given to everyone receiving makeup services.
- 7. Each Package that BB offers includes a set number of hair, makeup artists and/or assistants, as well as an approximate time that package takes to complete. If you have time constraints and an additional assistant is needed there is a \$150.00-\$200.00 additional fee per assistant.

Service Contract Part Three: Payment, Deposit, Cancellation and Travel Fee Policies

- 1. Payment is accepted in the form of cash, or credit card (visa or mastercard) via Square, **WE DO NOT ACCEPT CHECKS.**
- 2. **BB requires a 50% non-refundable deposit and completion of this contract to hold your wedding date.** This ensures that we will not book another wedding at the same time as yours. BB works on a first come, first serve basis.
- 3. If for some reason you need to cancel your services with BB: and cancellation is 30 days or prior to your wedding date there will be no additional penalty charges. If cancellation is between 29 and 15 days prior to your wedding date you will owe BB half of your invoice balance. If cancellation is 14 days or less prior to your wedding date you will owe BB the full remaining balance of your invoice balance. **With any cancellation, your 50% non-refundable deposit will not be returned.**
- 4. If you need to reschedule your services with BB: notice must be given 30 days prior to your scheduled wedding date. BB will need to determine if your new date is available. If your new wedding date is available, there will be a \$100 reschedule fee added to your invoice total. If your new wedding date is not available, then the cancellation policy applies.
- 5. BB Packages include 10 miles of travel from Wake Forest, NC at no additional charge. We will travel further but there is an additional travel fee and is as follows: 11 to 20 miles, \$25 per stylist, artist and assistant. 21-30 miles, \$50 per stylist, artist and assistant. 31-40 miles, \$60 per stylist, artist and assistant.

Applicable Law

This contract shall be governed by the laws of the County of Wake in the State of North Carolina and any applicable Federal law.

By signing this Service Contract with Bridal Bliss you are agreeing to the terms and conditions stated above. Bridal Bliss reserves the right to make any changes or revisions to this contract at any time and will notify Client in writing of any changes made.
