NCRS Nebraska Judging School for February 2020

The next meeting of the NCRS Nebraska Chapter will be on February 15, 2020 in Lincoln, NE. Using original photos sourced by NCRS & Corvette Hall of Fame member John Hinckley from the St. Louis Corvette plant, we will be installing a rear suspension in a 1968 Corvette. In a normal frame off restoration, the frame is set upright as it is driven, and individual pieces are placed under the chassis one by one. As seen in these photos from 1963, it is clear that the preassembled suspension was actually lowered onto an upside-down frame as an assembly and quickly bolted into place with just the two swing arm bolts and the two crossmember bolts. We will be using GM Photos, the TIMJG and instruction from actual GM Plant workers to install the differential, half shafts, swing arms, strut rods

and using a crane we will lower the entire assembly onto the upside-down frame and bolt it into place.



Since 1963-1982 Corvette frames are nearly identical, this judging school will be of interest to anyone that wants to learn about C2 or C3 Corvettes. This Judging School will explain why some bolts are installed “upside down” when looking at the chassis. We will also be using CDCIF to discuss components and hardware for Completeness, Installation & Finish.

The Judging School will be Saturday February 15 from 9-12am. The location is Brad Hillhouse’s shop: 3211 S. 6th Street, Lincoln, NE 68502. Coffee at 9am. Power Point presentation at 9:15. Parts assembly & installation at 10-12. This will be a one (1) point judging school that qualifies towards your Master Judge award.

I am going to try and present a similar judging school or tech session every month in 2020 to give people opportunities to learn more about Corvettes. Because of the date of the NCRS Lakeland Regional that I will be attending, our February meeting will be pushed forward one week to February 15. I will be hosting the chapter at my shop in Lincoln and the Judging School will be on the topic of C2-3 Corvette Chassis and Rear Suspension Installation. If we have enough interest, I have prepared a power point presentation on judging and how to handle disputes on the judging field. 


This was a technical seminar on installation of a C2 midyear under dash wiring harness on Osterholm's 1965 396 convertible. This included several examples of original and reproduction harnesses. The differences, and the installation.



Our Judging chairman, Brad Hillhouse, started the morning with introductions of the members and guests and then explaining the many manuals and reference materials available on the subject, with examples of all.



Brad then turned it over to chapter member James West. Who explained the disassembly process from the car, then laying out the harness on the bench and pre-attaching it to the dash pod before installation back into the car. Always explaining the Do's and Don'ts and points of extra care as he went along.



Then with the help of several members putting the entire harness with dash gauge pod back in the car.



James then explained the reattachment process while in the car doing the reassembly. Members were able to help hands on, in position to see the install, and ask questions during the operation.

Special thanks to John Osterholm who so generously welcomed us to his garage and use of his car for this seminar, and to James West for sharing his expertise and hands on knowledge on the subject.
