- 3. All vendors must be completely set up for inspection at least **1 HOUR** prior to the start of the event. All vehicles at that time must be removed from the park.*
- 4. Only approved food items as listed on the application may be sold.*
- 5. NO vendors may serve or sell *any beverages*.**
- 6. Participants will be responsible for securing and/or paying for any special permits that may be required by any governmental agency.*
- 7. You, your staff, and your booth must remain neat, clean and kept in an orderly fashion.*
- 8. Exhibits and displays must be contained within booth space.*
