In a filing to the U.S. Bankruptcy Court for the Southern District of New York, the Detroit-based automaker reported total assets of \$82.3 billion on a consolidated basis, with total debt of \$172.8 billion. A member of the Dow 30 Industrial Average, GM will be replaced by Cisco Systems Inc.
