(PAYPAL: Danceunlimitedstudiosreno@yahooCOM) (VENMO: GINA-HERNANDEZ-48) A \$30 late fee will be added to tuition on payments received after the 5 <sup>th</sup> of the month. Students are registering for the full school term (Sept-June), not for individual classes. The number of classes may vary per Month but the term is divided into 11 equal payments for your convenience. See registration package for mail in registration information. Classes start MONDAY AUGUST 19, 2024  Classes are not pro-rated for missed classes. A missed class must be made up within the month missed. Tuition and fees are non-refundable.  Full tuition is due for the months of December and June. NO tuition is deducted for snow days or holiday closures.  Students are required to have proper shoes/dance attire for each class. (See info sheet for specific information on attire)  If a student wishes to discontinue classes, A 30 day written notice must be given to the studio office. If proper notice is not received a withdrawal fee of one month's tuition is required.  In addition to monthly tuition, there are fees for registration, each recital held and costumes.  All fees must be paid in full before the due dates in order for dancers to participate in any studio events  STUDENTS ARE REQUIRED TO BUY/SELL 4 TICKETS AT EACH RECITAL PERFORMANCE. (DECEMBER/JUNE).
