- _____ **A 30 day written notice IS REQUIRED TO WITHDRAW FROM THE PROGRAM.** If proper written notice is not received a withdrawal fee of one month's tuition is required.
- _____ In addition to monthly tuition, there are fees for registration, each recital held and costumes. See information sheet
- _____ All fees must be paid in full before the due dates in order for dancers to participate in any studio events
