

## **COVID-19 Prevention Plan- Working Together**

### **Our Practice**

- Each child will have their temperature taken three times/day (drop off, nap time, after nap time). If the child has symptoms that include fever above 99 degrees Fahrenheit, headache, chills, repeated shaking, loss of taste or smell, burning eyes, rash (not related to diaper rash), or any other symptoms they will be sent home and cannot return to daycare until all symptoms have been gone for 24 hours.
- All adults in the facility are required to wear face masks at all times.
- Windows are kept open during the day to encourage circulation and fresh air.
- Toys and equipment (inside and outside) are cleaned twice a day (after nap and after daycare).
- Children's hands are washed at every activity transition (upon arrival, meal times, potty breaks, before and after all activities)
- Each child has their own utensils, plates, and cups for meals.
- Children have been separated into groups based on their ages to ensure proper distancing.
- Hard to clean toys have been removed from classroom (paper books, stuffed animals, pillows)

### **Your Agreement**

- If your child needs medication to reduce fever or any symptoms they are not allowed to attend daycare.
- If your child is three years old or older they are required to wear a face mask during activities.
- Children must be bathed daily, and brought in clean clothes while attending daycare.
- Personal Toys are kept in the car or at home.
- Parents/Guardians are required to wear a face mask upon pick up and drop off
- If there is a parent at the door before you during pick up and drop off please wait until they are back in their vehicle before you get down. Do not touch the door/door bell. My RING will allow me to see when you arrive and who is at the door.
- If you, your spouse/significant other, or child comes in contact with someone who has had COVID-19, they are required to be quarantined for fourteen days and tested for COVID-19. If you chose to cross state lines you must self-quarantine for fourteen days Mandated by our Governor.

## Covid-19 Prevention Plan- Working Together

The back of this page contains preventative measures that we are taking in the classroom as well as what we ask of you. Together we can do our best to prevent to the best of our ability Covid-19 from entering our classroom. This is a very serious pandemic and we ask that it is taken seriously by everyone. By signing this document you are agreeing to follow these practices and any others that will come in the future. We as a daycare will keep open conversation throughout this pandemic. If you have any concerns or recommendations please do not hesitate to ask or start the conversation. It is best that we remain calm for the children during this pandemic to ensure that we do not stress/frighten them, but rather teach them the importance of being safe. We can do this by practicing proper hand washing, wearing masks, and telling them not to put toys in their mouths because that is how germs are created.

We will get through this crazy time together by working together. If you the parents are feeling ill we ask that you keep your child at home with you even if they themselves do not feel/ seem sick. This will help prevent the possible spread of the virus. Temperatures and health checks are conducted three times a day and documented for each child during daycare hours. Should a parent or child test positive for Covid-19 the childcare will shut down for the ample amount of time directed by the department of health and deeply sanitized before re-opening. All parents will be notified immediately and required to be tested for Covid-19 and quarantined for fourteen days. Parents who come in contact with someone who has had Covid-19 and refuse themselves and their children to be tested for Covid-19 will not be allowed back in the childcare for fourteen days. If you cross state lines you are required to self-quarantine for 14 days to ensure that you are not exposed to the virus.

Remember, this is a stressful time for everyone. Please always be kind, courteous, and supportive to those around you. If we all take the required and recommended preventative measures it decreases the likelihood of the virus entering our classroom. We will do the best to our ability to keep your child and family safe and we ask for the same respect in return. Together we will get through this crazy time.

# COVID-19 Liability Release Waiver

## Audrianna Rodriguez Childcare

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the government has set recommendations, guidelines and some prohibitions which Audrianna Rodriguez Childcare adheres to comply.

- ☐ With full knowledge of the risks involved, I hereby release, waive, discharge Audrianna's Day Care, its board, officers, independent contractors, affiliates, employees, representatives, successors, and assigns from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me related to COVID-19 while participating in any activity while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19
