



## Liability and Consent Form for Boarding and Daycamp

Ruff-Inn-It, LCC and the owner of the pet(s) (hereafter referred to as Owner) to be admitted into boarding/daycamp hereby agree as follows:

### Boarding and Daycamp

Owner agrees to pick-up their pet(s) by 1 pm on weekdays for boarding and by 6 pm on weekdays for daycamp. Owner agrees to pick-up their pet(s) by 12 pm on the weekend for boarding and daycamp pet(s). Pick-ups after these times will incur a late fee of \$10. Any pick-ups or drop-offs that may occur after Ruff-Inn-It's operating hours must be authorized by Ruff-Inn-It staff. Owner understands that any pet(s) not picked up by the times stated above on any day of the week, disregarding authorized late pick-ups, will be assigned a boarding suite for an additional overnight care fee of \$38. Owner understands that any pet(s) not picked up within 30 days of the expected pick-up date without contact from Owner will be considered abandoned, and Ruff-Inn-It will assume ownership with the rights to place the pet at Ruff-Inn-It's discretion.

### Necessary Information and Dog Health

Owner agrees to provide Ruff-Inn-It with any necessary information about themselves and the pet(s), including but not limited to: Name, Breed, Age, Weight, etc. Owner agrees to provide correct veterinarian information for the pet(s) and up-to-date vaccination records that show required vaccinations:

**DOG:** Rabies, Distemper, Lepto, Canine Influenza (H3N2, H3N8), Bordetella (updated every 6 months)

**CAT:** Rabies, Feline Distemper, Feline Leukemia

Owner understands a letter from the veterinarian must be on file and given to Ruff-Inn-It for their records for any vaccination exemptions related to age, chronic illness, or vaccination reaction. "Owner does not want pet(s) to receive vaccination" is not a valid reason, and entry for daycamp or boarding can be denied by Ruff-Inn-It staff.

Owner understands that no vaccinations offer 100% protection from any disease, and exposure is still possible.

### Liability and Indemnification

Ruff-Inn-It will exercise reasonable care of the pet(s) during their stay. Owner does acknowledge and understand that pet(s) nature can be unpredictable outside of their home, which can lead to small cuts, scrapes, or other minor injuries. In consideration of this, Owner agrees not to hold Ruff-Inn-It, its officers, owners, employees and agents liable for these injuries.

### Co-Mingling Consent

Owner consent to allow pet(s) to co-mingle with others of the same species is required for daycamp and all indoor/outdoor play for dogs and free-roaming for cats. In both environments listed above, Owner acknowledges there are risks associated with daycamp and boarding, including but not limited to cuts, scrapes, puncture wounds, illness, or other minor injuries related to normal dog play. Owner agrees not to hold Ruff-Inn-It, its officers, owners, employees and agents liable for any injuries in these cases.

**Emergency Veterinary Care**

For any illness or injuries, Ruff-Inn-It will first contact Owner. If Owner is not able to be reached, the signature on this form grants permission for Ruff-Inn-It to act in the pet(s) best interest, including contacting the vet. If the primary vet is unavailable, Owner agrees to allow Ruff-Inn-It to contact their emergency vet contact, Bel Aire Pet Clinic or Animal Emergency Clinic of Springfield.
