Exam

Foundation Exam

Exam vouchers may be purchased, allowing to take the remote-proctored exam online on the ISACA website.

The COBIT® Foundation exam is designed to test the candidate's knowledge of the framework as opposed to memorization.

Specific exam information includes:

- Closed book, online proctored exam
- 75 multiple choice questions
- One correct answer for each question, using three choices (A, B or C)
- Two hours (120 minutes) are foreseen to complete the exam
- Pass rate is 65% or 49 correct answers out of 75



COBIT® 2019 Foundation Training Format

The COBIT® 2019 Foundation training class format is as follows

- Two consecutive days training
- Third day for the exam and preparation
 - Half-day exam preparatory morning session
 - A two-hour certification exam, consisting of 75 questions

Training Provider

Language

All documentation is in English.

Tarif

The cost of training amounts to:
