Organization's Responsibilities

Pay their balance upon arrival.

Submit completed Tuition Camp Registration Forms for each Camper.

Submit for CrossView approval completed Counselor Applications for each Counselor candidate as early as possible before scheduled week of Camp.

Provide Sexual Abuse Prevention Training to each Counselor and submit completed tests to CrossView.

Bring a maximum of (CrossView preapproved) 2 male and 2 female Counselors who are mature Christian adults suited to the ministry of Summer Camp spiritually, emotionally, and physically.

Go over CrossView's rules with Campers & Counselors before Camp.

Use Camp property with care & cover damages caused by misuse.

Respect the beliefs in CrossView's Statement of Faith.

Provide transportation to and from Camp.

Counselors

Your organization provides a maximum of 2 male and 2 female Counselors. Counselors must be at least 18 years old.

All Counselors must be mature Christians suited for the ministry of Summer Camp



spiritually, physically, and emotionally. They must be able to handle summer outdoor temperatures, lots of walking (including uphill), and a very active schedule.

Counselors cannot be tobacco users. CrossView does not allow tobacco

products on the property, and Counselors must remain with their Campers at all times; so there is no opportunity for tobacco use.

Volunteer Counselors must apply to serve at CrossView. Volunteer Applications are available on the Camp's website or upon request. The Camp runs background checks on all Counselors, contacts references, and conducts interviews to determine each applicant's suitability to the ministry of Summer Camp. Organizations should submit Volunteer Applications as early as possible so that in the event any are rejected, there is ample time to find replacement(s).

Your organization will give all Counselors a Sexual Abuse Prevention Training and Test (curriculum and test provided by CrossView).

Our goal is for Counselors to bond with the Campers during Camp and become mentors when the "sprint" of Summer Camp is over and the "marathon" of discipleship begins.
