## POOL EVENT CONTRACT

This is a legal and binding contract between the Organization and CrossView Christian Camp & Retreat Center. Please answer every question, obtain both required signatures, make and keep a copy for your records, and return the original to CrossView Camp along with your \$100 deposit.

### PAYMENT COMMITMENT

The Organization will pay CrossView Camp a deposit of \$100 to reserve the date of their Pool Event. The Organization will pay the balance of their bill upon arrival at CrossView Camp. If the Organization must cancel their Pool Event for any reason, their \$100 deposit is not refundable unless CrossView is able to book another Pool Event for that date.

The Pool Event will begin at the time designated on this contract, regardless of the Group's arrival time. The pool will close and be evacuated at the time designated on this contract, regardless of the Group's actual swim time, and the Group will have a maximum of 30 minutes to pack, clean, and leave Camp property.

Guests include everyone present on CrossView property for the Pool Event. Guests exceeding the number indicated above will not be allowed on the property for any reason. Refunds will not be given if fewer Guests attend than were estimated.

Pool Event fees include: Guests up to 35 or 70 (depending on number indicated on this contract), 1 porta potty stocked with toilet paper and hand sanitizer, lifeguard(s) (1 for up to 35 guests and 2 for 36-70 guests), trash can with liners, 2 picnic tables on pool deck, and use of pool and diving board.

Guests will not have access to any CrossView facilities other than those rented. (For example, if the Kitchen/Dining Hall is not rented, Guests may not have access to that facility for any reason, including the bathrooms.)

If inclement weather prohibits swimming for more than half of the scheduled pool event, a make-up date can be scheduled, subject to availability. No refunds will be issued because of inclement weather. The Camp Director and/or lifeguard will decide if weather requires a pool evacuation.

The Organization agrees to use all Camp facilities and equipment with care and agrees to cover the cost of any damage caused by careless, reckless, or negligent behavior on behalf of Guests.

## OTHER RESPONSIBILITIES OF ORGANIZATION

The Organization agrees to respect the Christian beliefs of CrossView Camp and to do nothing by word or deed that will in any way detract from the purpose or testimony of CrossView Christian Camp & Retreat Center.

The Organization agrees to go over CrossView's Pool Event Rules with all their Guests and to enforce these rules. The minimum adult to child ratio is one adult per 10 children (under 18 years old).

## CROSSVIEW'S POOL EVENT RULES

1. Swimmers must wear appropriate swimwear.
2. All non-potty trained swimmers must wear a swim diaper and be monitored closely for accidents. If the pool becomes contaminated with human waste, an extra clean up fee will be charged.
3. No running, dunking, pushing, horseplay, etc.
4. No flips or back dives from side of pool.
5. No hanging on rope.
6. No food or drink in the pool, and no glass containers, pets, or animals in pool area.
7. Obey lifeguards.
8. Stay in appropriate area for your swimming level.
9. Those with mouth, nose, or ear discharge, skin lesions, or any communicable disease may not use pool without written permission from a medical professional.
10. Dive only in designated areas.
11. Spitting, spouting water, blowing nose, urinating, and defecating in pool is prohibited.
13. One person allowed on the diving board at a time.
14. Only one bounce allowed on the diving board.
15. Look before diving or jumping to make sure diving area is clear.
16. Dive or jump straight off the diving board, then exit to the nearest ladder.
17. No dangerous stunt diving, hand stands, etc.
18. Keep area in front of diving board clear.
19. No swimming under the diving board.
20. No alcohol or tobacco in any form on Camp property.
21. Firearms, fireworks, airsoft guns, pets, and other destructive/damaging items are prohibited.
22. All vehicles must be parked in the designated visitor parking and remain there for the duration of the Pool Event. Only **adult** licensed drivers (at least 18 years old) may drive on Camp property. Children (younger than 18 years old) may not ride in the bed of a truck on Camp property.
23. Crude or obscene language will not be permitted. Jokes, songs, stories, gestures, slang, etc. must all be God-honoring.
