Cotton Harvest Mercantile Application Saturday, October 21 10 a.m. – 9 p.m.

1. Merchant spaces are 10'x10' per \$75.00 fee. Merchant is responsible for canopy tent/awning, backdrops, tables, chairs, and anything else required to display **within** a 10'x10' square space. Weights/sand bags/stakes must anchor tents (space is on grass).
2. Electricity is provided (**limit to 1 plug**). Merchant to provide outlet strip and an outdoor extension cord (minimum 100 ft).
3. Any type of merchant that will operate out of a trailer for food sales will be considered a food trailer and will **not** use this form.
4. Collection and remittance of Texas Sales Tax is exhibitor's responsibility.
5. Vehicles **are not** allowed on grassy lot.
6. Merchants are responsible for cleaning up trash/debris in their space at the end of the evening.
7. Merchants will be set up and ready by 9:45 a.m. – no exceptions. Fee will be forfeited.
8. Merchants must keep business open until closing at 9 p.m.
