

Cotton Harvest Food Merchant Application Saturday, October 21 10 a.m. – 9 p.m.

1. Space is Limited. First come, first serve. Approved application AND payment is confirmation of entry to festival.
2. Merchant spaces are 20'L x 10'W per \$150.00 fee. Anything over 5 additional feet will not be allowed.
Measurement of entire trailer bumper to hitch/tongue: _____ Attach a photo of trailer.
3. Electricity is provided. Merchant to provide all supplies for hook-up of trailer. **AMP Required:** _____
4. Do NOT connect anything in addition after electrical inspection. If you choose to and trip - you will be asked to disconnect.
If it causes damage to the electrical outlet/panel, you will be charged for the expense to have repaired.
5. Merchants must have on display a food handler's permit and provide proof of liability insurance.
6. Collection and remittance of Texas Sales Tax is merchant's responsibility.
7. Merchants are responsible for cleaning up trash/debris in their space at the end of the evening.
8. Merchants will be set up and ready no later than 9:30 a.m. – no exceptions. Fee will be forfeited.
9. Merchants must keep business open until closing at 9 p.m.
