#### PROGRAM MANAGEMENT

Led the team at Denver International Airport managing multiple Rolling Owner Controlled Insurance Programs insuring over \$4B in construction projects; established key performance metrics centered on safety, small business growth, and cost avoidance and further expanded the focus on safety through added staff, dashboards and training initiatives to ensure program success.

#### STRATEGIC PLANNING

#### **INSURANCE PROGRAM INNOVATION**

From concept-to design-to execution, established a unique insurance program providing Excess Auto Liability at Denver International Airport to make it easier for companies to obtain the required \$10M limit to drive unescorted airside. This program reduces barriers for small business by offering coverage estimated to save 70% on insurance premiums and is structured to be a net zero cost to the airport.

#### PROJECT MANAGEMENT

Spearheaded acquisition integration of two former competing insurance brokerages into a single collaborative, multi-location entity. Focusing on areas of Compensation and Rewards, Licensing and Contracts, Marketing (internal and external), Procedures and Forms, Talent Management and Technology. Initial outcomes resulted in staff engagement, office consistencies and collaborative strategies for continued growth.

#### SYSTEM AND PROCESS IMPROVEMENT
