DAY 1 – Arrival in Buenos Aires | Recoleta & Palermo by Bike | Welcome Dinner



Welcome to Buenos Aires! After check-in at Casa Lucía (a Meliá Collection property)—a stylish and sophisticated hotel in the heart of the city, enjoy some time to relax and have lunch at your leisure.

In the afternoon, hop on a bike to explore Recoleta and Palermo. Discover early 20th century architecture, gorgeous parks, sculpture gardens, and landmarks like the Japanese Garden and Victoria Ocampo's residence.

In the evening, enjoy a curated welcome dinner at *Fogón Asado*, an immersive open-fire dining experience unlike any other. This acclaimed closed-door restaurant reimagines Argentina's iconic asado through a modern lens—offering fire-roasted meats, seasonal dishes, and storytelling that honors culinary heritage. Every dish is carefully paired with premium Argentine wines to elevate the evening.

DAY 2 – Old City Tour & Street Food Experience

Today, we dive into the historical and culinary roots of Buenos Aires. Enjoy a walking tour through Plaza de Mayo, La Boca, and San Telmo while sampling some of Argentina's favorite bites: *tostado*, *choripán*, fried empanadas, classic *muzza* pizza, and artisanal ice cream.





In the evening, enjoy an optional dinner at *Roux*, an acclaimed fine-dining restaurant in Recoleta known for contemporary cuisine and refined flavors.

Optional add-on: Rojo Tango show at the Faena Hotel (includes roundtrip transfers).

DAY 3 – Buenos Aires to Mendoza | Lunch at Casa Vigil

Morning flight to Mendoza. On arrival, transfer to Luján de Cuyo, the cradle of Malbec.

En route, stop for a gourmet 3-course lunch and wine pairing at *Casa Vigil*, one of Argentina's most lauded wineries—home to legendary winemaker Alejandro Vigil, the visionary behind El Enemigo wines and widely regarded as Argentina's most influential vintner.





Enjoy the afternoon at leisure after checking into Entre Cielos Luxury Wine Hotel & Spa, or similar.

Key Views: Andes foothills • Casa Vigil winery • Maipú vineyards



DAY 4 – Catena Zapata & Susana Balbo

Start your day with a visit and a wine tasting in *Catena Zapata*, an iconic and highly acclaimed winery, renowned for its pioneering role in elevating Argentine wines to world-class status, particularly Malbec. With a history dating back to 1902, the family-run estate is celebrated for its high-altitude vineyards, meticulous viticultural practices, and groundbreaking research. Their stunning, pyramid-shaped winery is a recognizable landmark, and their wines consistently receive top international accolades, representing the pinnacle of Argentine winemaking and terroir expression.





Afterwards, you will enjoy a visit and 4 course wine paired lunch at *Susana Balbo Winery*, a modern and innovative estate founded by one of Argentina's most respected and influential winemakers, Susana Balbo. Known for her pioneering spirit and dedication to quality, the winery produces a diverse range of high-end wines, with a particular focus on expressing the unique terroir of different Mendoza sub-regions. Elegant architecture, exceptional wines and flavors and a deep dive into the passionate winemaking philosophy of its namesake.

Dinner: **Azafran**, the best restaurant in Mendoza's town. It offers delicious gourmet cuisine and a wide range of wines.

Key Views: Catena's pyramid winery • Susana Balbo vineyards • Wine tasting rooms



DAY 5 - Vineyard Biking Tour | Viamonte & Lagarde | Transfer to Uco Valley

Ride through vineyard-lined paths and mountain vistas. Visit *Viamonte*, a boutique family-owned winery, and enjoy a tasting among the vines.



Continue to *Lagarde*, one of the oldest and most distinguished estates in the region, for a leisurely 4-course lunch. This is a historic and family-owned estate, with a legacy dating back to 1897. Known for its exceptional Malbec, Lagarde blends tradition with modern winemaking techniques. Here, you will experience the charm of their old vines and colonial-style architecture while savoring a 4 course wine paired lunch with their elegant and age-worthy wines, surrounded by beautiful vineyard views.

After lunch, transfer to the Uco Valley and check in to Casa de Uco Wine Hotel & Spa, or similar.

Key Views: Andes mountain bike route • Viamonte cellar • Lagarde estate



DAY 6 – Uco Valley Icons | Rolland & Zuccardi

Begin your day with a barrel tasting and iconic wine experience at *Bodega Rolland*, founded by famed French winemaker Michel Rolland.

Continue to **Zuccardi Valle de Uco**, voted World's Best Vineyard three years in a row. Enjoy an exceptional guided visit and a 8 course wine paired lunch at **Piedra Infinita**, a truly memorable experience.







Return to the hotel for an afternoon of relaxation.

Dinner suggestion (optional): Rope, the restaurant at Bodega La Vigilia. It features beautiful views and contemporary signature cuisine. They offer an à la carte menu with exquisite dishes showcasing Argentine flavors.

Kev Views: Clos de los Siete hills • Zuccardi • Gourmet wine lunch

DAY 7 – Andes Horseback Ride & Barbecue

Saddle up for a scenic horseback ride through the Andes with a local mountain guide. End the adventure with a traditional Argentine barbecue paired with regional wines.

DAY 8 – Farewell Tasting at Piedra Negra | Departure

Check out after breakfast and stop at *Piedra Negra*, pioneers of organic winemaking in Uco Valley, for a farewell tasting paired with *picada* (Argentine cheese, olives, and charcuterie). A delicious farewell to this journey filled with flavor, passion and terroir





Transfer to Mendoza Airport for your return flight to Buenos Aires, followed by transfer to Ezeiza International Airport for your international flight home.

- A separate amount will be charged by the Argentina-based partner travel agency once services are confirmed. This will include a portion of the total trip cost and will be communicated to travelers once available.
- Final balance will also be collected by the Argentina local travel operator approximately 30 days prior to departure, pending confirmation of dates and payment structure.
- This agreement remains binding for participation in the trip as described in the final itinerary and invoice, whether pricing is adjusted after signing.

CANCELLATION TERMS: Cancellation terms are based on the policies of our Argentina-based partner travel agency.
