Recognition Pins:

It is disappointing to note that clubs still have not taken the opportunity to request the PCQ volunteer pin, and while is only a small token of recognition, it does acknowledge the value of these workers in our clubs. Clubs rely heavily on this working group and while these volunteers provide the hard yards and don't expect to be rewarded, the occasional thank you is always welcomed. Please review your required quantities and advise the office if you have not already done so. These lapel pins are provided to clubs at no cost.

PCQ Marketing SteerCo'26:

The inaugural meeting of the Marketing group was held at the end of February with a number of pillars being determined. A second meeting was held several weeks later which provided some insight into the group members' experience, key strengths and pony club involvement.

Game Plan:

As advised back in February 2024, this is a free resource that is available through the Australian Sports Commission to State authority, zones and clubs. Game Plan is a tool designed to measure, develop and improve the capability of all levels of sport. Game Plan replaced the previous Health Check portal.

I can't stress enough the importance for zones and clubs to register their association with Game Plan. Future funding opportunities at all levels of pony club may depend on registration with the Game Plan platform.

While there has been an increase in the number of clubs that have registered from 24 to 51 (27.42%) of clubs registered leaving 135 (72.58%) of clubs still to register. Nine zones have now registered with 14 zones still to register. For those clubs and zones that have registered I strongly encourage you to be proactive and work through the modules and plans on the Game Plan platform.

Simplified Governance:

As reported in February, PCQ is currently developing a Simplified Governance document for the state, zone and club levels, it was hoped to have completed this earlier, but unfortunately this has been delayed. It is now hoped to have this completed this month.

Sport & Recreation Qld:

It is my understanding that Sport & Rec Qld has reached out to those clubs that may have been affected by TC Alfred. If your club has sustained damage and has not heard from the Department, I would recommend you go to the website at www.qld.gov.au/recreation/sport/funding/disaster-recovery to access the Disaster Recovery Program funding. This program provides \$5000 in funding to support immediate clean-up efforts. I would also encourage any club affected in the disaster-activated areas to apply for the funding.

Clubs that are affected are also asked (when able), to advise PCQ and if possible, also provide some photos.

Member Survey:

In late September, PCQ asked members to complete a survey to assist in helping PCQ serve members better. PCQ received 302 responses to this survey. The overall outcome of this survey was very positive however there were some areas of concern comprising bullying and poor morale at club level, toxic environments, frequency of rallies, new member club induction and age groups. The Executive is looking at ways these concerns may be addressed.

Zone Model Rules (Constitution):

It has been noted that some current zone constitutions are outdated and don't differentiate between Executive and Management, which may cause issues. To assist Zones in adopting an updated constitution, a more suitable document has been drafted and once reviewed by our legal advisors will be made available to Zones.

2026 State Championship Events:

In an effort to provide opportunities for clubs/zones to host these championship events and for riders to be aware well in advance, applications for all the 2026 State Championship events are now open.

The Admin Office will have sent a communication to clubs and zones advising this, with the closing date for applications being the 16th June 2025.

MPIO's/Complaint Handling:

As previously advised PCQ now has three (3) qualified MPIOs to provide procedural information to members. Where possible all queries should now be directed through the MPIO email address at mpio@ponyclubqld.com.au for action or contact the PCQ Admin Office for a contact number. With three MPIOs in place, our previous MPIO Melda McBeath has now transitioned to the Complaints Handler role while still mentoring and providing support to the MPIOs.

National Fire Ant Eradication Program:

As previously advised, PCQ receives regular updates which are forwarded to clubs and zones in the targeted areas as well as being uploaded onto the PCQ website and Facebook pages. Fire ants are a serious bio-security threat, and clubs and members need to be vigilant.

When renewing/purchasing membership on the JustGo database members will be unable to join as a Coach unless the details are showing in the credential section of their profile.

NCAS – PCA National Preliminary and Level 1 Coaches are required to submit a signed Re-registration Form and Activity Sheet every four (4) years. Transfers on JustGo:

For those who have already purchased membership for the current year and transfer to another club: Secretary of incoming club accepts the transfer > rider goes into profile on JustGo database > Go to Membership > click on the Club they have transferred to > click on the Membership category they have joined under > Payment. The PCA & PCQ fees will come up as minus, but they will then pay the new club fee

When this process is completed, the member will show up as being a current financial member of new club. If this process is not completed the member may sit in new club membership as a member of old club.

Horse Registrations:

To reduce the quantity of pending registrations from 01/01/2025 all Official registrations that have not been paid for will be cancelled unless payment is received by the end of June.

If riders are wishing to compete in the Official section of Dressage, Combined Training, ODE, Jumping Equitation or Showjumping the horse **must** be registered, and the rider **must** have the appropriate card.

2025.0408 State Coaching Panel Report

Items highlighted:

- The update of the SCI Medals is going well, with continuing applications being received. Also, photos of award presentations to be sent to PCQ.
- Query raised re: selection process for the 2025 Nationals. The meeting was advised, the process is similar to previous years with the required form to be submitted to PCQ for the subcommittees to review and give final approval. The SCI also advised the Inclusion of Riders with Special Needs and the Para Class is more of a demonstration rather than a competition. Also note, any rider competing in the Masters section must also hold a C Riding Certificate or a PCA Coaching level to compete. If needing to obtain a C riding certificate the D & D* must first be completed as per current PCA rules. The form has been sent to zones for onforwarding to clubs and is also on the PCQ website under resources>forms>club. Please note the 2025 Nationals will be held at the Werribee Park Equestrian Centre Victoria from the 1st to 5th October 2025.

I am pleased to present my report for the January – March 2025 period along with supporting documentation.

Income & Expenditure:

As expected, all three months recorded operating profits with the bulk of the income received from membership fees along with horse registrations, open days and come and try participation. There were no unexpected expenses with the annual insurance premiums for management liability, cyber, equipment and care custody being paid in January and March. A cross-country subsidy was also paid to Greenbank PC in January.

ATO Annual Self-Review Reporting Obligation:

QId Family & Child Commission (QFCC) Grant:

The QFCC has opened submissions for grant funding from \$10,000 to \$90,000 to enable organisations to strengthen child safety practices in preparation of the upcoming changes to child safety legislation in Queensland. An application has been submitted to support PCQ's compliance and best practices in child safety

Volunteering Queensland Conference:

I was fortunate to have attended this 2-day conference in Brisbane, of particular interest was a presentation by Alice Husband from Justice Connect's NFP Law (<u>www.nfplaw.org.au</u>)

Changes to the Community Coaching Essential Skills Course

As of **April 9**^{th,} **2025**, the updated version of the Community Coaching Essential Skills course will go live to all learner coaches.

What will change

- You will have the option to complete the modules in any order and as many as you wish (or are required as per NSO/NSOD requirements).
- The Safeguarding module in the Community Coaching Essential Skills course will be removed. All safeguarding content will be completed via <u>Sport Integrity Australia's</u> <u>Safeguarding Children and Young People in Sport Induction course.</u>
- You will have access to reflective workbooks that align with each of the 7 essential skills module topics.
- You will gain an award upon successful completion of each module and a certificate when you have completed all 7 modules.

What won't change

- The learning objectives and topics covered will remain as within the current course and still deliver on the fundamentals of coaching.
- The diverse learning opportunities throughout the course.
- The course remains free for all learners to access and continue their coaching development.

What if I'm already completing the current Community Coaching Essential Skills course?

- The updated Community Coaching Essential Skills course will not go live until April 9th, 2025, so you have until then to complete the current version.
- If you do not complete the entire Community Coaching Essential Skills course by April 9th, 2025, but you have completed one or multiple modules within the course (e.g. up to Module 4: How you connect), you will receive an award for each module completed but not a course completion certificate. You will still need to complete all modules to receive a course completion certificate.
- If you did not complete past Module 1: Who you coach, you will be required to start the course again should you choose.

What if I have already completed the Community Coaching Essential Skills course?

• You don't need to do anything; your previous completion is already registered.
