# SCOPE OF PRACTICE

- Psychologists will be expected to have a sound ability to apply theory derived from evidence-based practice in the areas of mental health, disability, and chronic health conditions. They will have highly developed skills in the delivery of mental health assessment and interventions to people of all ages with a wide variety of presenting conditions. They will work with clients and their families, carers and support staff using a client focused approach. They will work closely with administration staff, referrers, and other clinical staff.
- Clinical practice is undertaken within an individual's area and level of expertise and with due regard to ethical, legal, organisational, and profession-prescribed standards, and also ensures that the providers of clinical interventions occurring on site are also delivered to clients and their families with due regard to ethical, legal, organisational, and profession-prescribed standards.
- Staff may be required to work across multiple sites within Newcastle and surrounding areas, dependent on service needs.

# **KEY RESPONSIBILITIES**

#### SERVICE DELIVERY

- Provide high quality, evidenced based mental health assessment and treatment for mental health conditions, and associated psychosocial issues.
- Participate in clinical review processes
- Effectively manage clinical case load and participate in audit processes

- Contribute to a clinical culture that is characterised by quality and safe care, and respect for clients and their families/carers
- Maintain appropriate clinical documentation
- Ensure that appropriate communication with referring agencies is maintained
- Ensure that all legal requirements, including child protection and privacy, are fulfilled
- Ensure data collection protocols are followed

#### SERVICE SUPPORT AND DEVELOPMENT

- · Actively contribute to the New Ability Health team in building a quality service
- Contribute to creating a welcoming and accepting environment
- Promote the philosophy and values of New Ability Health
- Contribute to the learning culture of New Ability Health
- Work collaboratively with all New Ability Health staff to ensure a quality service to clients
- Build and maintain effective working relationships with other services
- Participate in New Ability Health quality improvement activities
- Participate in professional clinical supervision where required

- Relevant tertiary qualifications in Psychology
- General registration as a psychologist with AHPRA / Psychology Board of Australia (applicants at the completion stage of postgraduate programs will be considered if they can demonstrate successful completion of course requirements).
- Demonstrated experience in the delivery of mental health assessment and interventions to individuals across the lifespan with a wide variety of presenting conditions.
- Excellent communication skills, including experience communicating with a diverse range of customers, including those with mental health, physical and intellectual disabilities.
- Excellent time management and organisation skills with a keen attention to detail.
- Demonstrated ability to learn new electronic systems.
- Able to use initiative to identify areas for improvement and implement changes.
- Demonstrated experience and flexibility in learning and adapting to new systems.
- Demonstrated capacity to work autonomously, while being part of a team.

#### DESIRABLE CRITERIA

- Demonstrated experience working in a multidisciplinary health service environment with clinical and administrative staff.
- Demonstrated experience working in the areas of chronic health conditions, rehabilitation and disability.
- Familiarity with clinical/medical software programs (ideally Healthkit / Halaxy) and billing procedures
- Familiarity with NDIS system and required documentation and billing procedures
- Familiarity with Medicare system and required documentation and billing procedures
