(If you are only in ONE class you will only need to attend ONE rehearsal)

**Costume Payments:** Costume WILL NOT be ordered for anyone PAST DUE on payments!

VENMO preferred but also Paypal, Cash/Cr-Debit Card/ Cks made payable to OCD

Do not combine amounts on checks....example (tuition and costume payments)

**January 30<sup>th</sup>---50% of entire balance for all costumes....NEW or PRE-OWNED costumes**

**February 27<sup>th</sup>—Entire Costume balance for all costumes....NEW or PRE-OWNED costumes**

### Policies before Signing Permission Slip:

#### I understand & agree

1. **MOST IMPORTANT:** All Dancers participating in the recital **MUST ATTEND CLASSES IN STUDIO** and **NOT on ZOOM!** Unfortunately, the choreographers cannot place you in a spot in the dance if you're are not physically **IN** the studio.
2. Costume money **WILL NOT** be Refunded for any reason if dancer Can't participate & costume balance must be paid in **FULL**.
3. Pre-Owned Costumes will be arranged by the studio and New owner will submit payment **BEFORE** receiving the costume.
4. If for any reason beyond our control, we cannot have the recital for above dates, costumes **CAN NOT** be refunded. We will in every way try to hold the recital on a different date.
5. Dancer **MUST** attend classes on a regular basis if participating in the recital otherwise they will **NOT** be permitted to participate or will be excluded from parts of the dance.
6. If there are any outstanding costume/tuition balance due, dancer **Will NOT** receive his/her costume until bill is paid in **FULL**.
7. Dancer **MUST** attend **ALL DRESS REHEARSALS** in order to participate in the recital.
8. I, as well as our friends & family will abide by all policies for the recital, otherwise removal from the premises will take place. Anyone watching the show, **MUST BUY A TICKET** otherwise you will be asked to leave the premises.
9. The day of the show, **ALL** dancers will arrive 1 hour before the show is to begin even if you don't dance until Act II unless plans need to be changed due to COVID and at that point you will be given a specific time in order for the dressing rooms to be not as crowded.
10. Professional etiquette states that costumes are **NOT** to be worn other than when on stage **HOWEVER** this year we may have to have dancers arrive in their first costume so as to eliminate crowding in the dressing room.
11. The day of the show, all younger dancers will need to arrive in their costume. **ONLY** younger dancers that have a costume change will be permitted to have **ONE** parent enter the building after obtaining a security bracelet to help dress dancer.
12. The day of the show, all dancers **MUST** remain in dressing room until Intermission or the end of the show.
13. For Security reasons, Dancers **ARE** expected to **STAY** in the building until dismissed.
14. **NO** photography, videotaping or use of cell phones will be permitted during the shows however you are permitted to video tape during the rehearsals.
15. We will be respectful to all OCD staff during the week of the recitals. They are **VOLUNTEERS!** Let's make it a **FUN** week!
