## V. Speaker: Monica Ubals, MS

Nancy J. Cotterman Center Human Trafficking Team - Behavior Health Clinician

- The Human Trafficking Team strives to conduct education in the community. This includes talking to young people in schools and in foster homes about human trafficking risks and social media as a means for recruiting. It also includes speaking with medical providers about red flags and how to recognize signs of HT, such as frequent STI's.
- Additionally, the team collaborates with some businesses in the community by placing a QR code for the Nancy J. Cotterman Center in the bathrooms.

- Services offered to survivors include intensive case management, referrals, legal help, immigration assistance, referrals for medical and dental health. May also assist youth with having criminal charges dropped if they have been arrested under the age of 18 and have also been identified as an HT victim. They need to complete the program and community service.
- There are boys and girls groups that take place for kids displaying risky behaviors.
- The team works collaboratively with the IRC, the Flite Center, and the Office of the State Attorney.
- Recent events include the Youth Summit on 1/13 to raise awareness for youth and the Action Speaks event at Boyd Anderson High School.
- Referral forms are available for youth who are displaying risky behaviors.

## VI. New Business

- A. NCVRW Sandra Vazquez
  - National Crime Victim's Rights Week is coming up in April. We will have a Garden Committee, Awards Committee, and Training Committee for the membership to collaborate on all preparation efforts.
    - 1. Garden Committee
      - Applications for engravings at the garden will be available of the BVRC website.
      - The deadline to receive the applications will be 2/19/24. A proof of crime is needed.
      - Engravings cost \$75, however the fee can be waived if there is a hardship. No victims have paid for their engravings in the past 3 years.
      - The vigil will be on Tuesday, April 23<sup>rd</sup> at the garden.
      - The garden committee will be asked to help paint rocks for the garden.
      - On the day of the vigil, committee members should arrive at approximately 4:30pm. The event will start at 5:30 and the attendees will move into the garden at about 6pm.
    - 2. Awards Committee
      - A sign-up sheet is going around for the award's committee. It is a low time commitment.
      - The committee will update the award's nomination form with this year's categories.
      - We are renaming the Volunteer of the Year Award to the Barbara Koeppel Volunteer of the Year Award. We are also splitting the Law Enforcement Officer/Prosecutor of the Year Award into two separate categories.
      - The committee will also identify a group to judge the awards. In previous years we have used interns and classes. If anyone knows of any groups that may be able to judge, please let us know.
    - 3. Training Committee

- A location needs to be identified for the annual training/luncheon. It is ideal if there are two rooms.
- Working with TTAC on selecting a training topic. There is one offered on cultural competency.
- The annual training is tentatively scheduled for 4/25/24.
- Arc Broward does cater, and they are an option. Please let us know if anyone knows of any other caterers.
- Suggestions for a venue include the Holiday Inn or a Lauderhill park.
