5. Biggin Hill

The KVRA Monitoring Exercise is focused on incursions into the Keston Noise Sensitive Area (NSA) by helicopters. Year to date 22 helicopters have been reported. The Airport's investigation into these has revealed that 18 pilots and/or operators have been referred to the Airport's Safety and Noise Action Board (SANARB) as there was no apparent mitigation for their incursion across the Keston NSA. So far SANARB has issued 5 written warnings to these pilots and/or operators.

Peter Zieminski, the KVRA's representative on the Biggin Hill Airport Consultative Committee (BHACC) will attend a meeting with David Winstanley, the Airport's CEO, on the 17th of June 2025 to discuss these complaints and also to help draft the terms of reference for the newly created Working Parties which will examine 1. The complaints process and 2. The establishment of Key Performance Indicators, as part of the work of the Airport's Residents Noise Action Forum (ARNAF).

Peter and Shelley will attend the next ARNAF meeting on the 15th of July to hear about progress towards the implementation of the promised revision of the boundaries of the Keston NSA and the new approach to Runway 03 Trial, scheduled for quarter three of this year.

6. Planning

- (a) Cllr Michael will 'Call in' the application from Oakshaw Farm.
- (b) All other applications were deemed non-contentious.
- (c) Cllr Michael said the Government's consultation document on the Reform of Planning Committees had been issued. She asked if KVRA could respond to the public consultation. In essence, it will mean the removal of local democratic decision making from all but the largest planning applications (and then only in principle). 'Call-in' will be abolished. Very few Councillors will be 'allowed' to sit on planning committees to make the decisions that are permitted to them.
