UNDER PENALTIES OF PERJURY, I, Charles Jenkins, hereby affirm and /or attest that the fallowing statement is true and correct and a product of my own free will.

Where upon I was named a victim in the case of: Sharrod Holmes v. State of Florida, Case No: 05-04927-CF, and in said case I was testifying witness for the State Attorney in and for Pinellas County, Florida as a named victim.

In this case, I was familiar with Mr. Holmes by name only, but had seen him around neighborhoods in which I frequently visited with disassociated friends.

As I testified in Mr. Holmes' trial, I never suggested to investigating officers or the prosecutor that it was Mr. Holmes who was the perpetrator that had been involved in or was responsible for the shooting in the case, nor was it he who I had been chased by running from a person with a firearm.

As I indicated in my testimony at trial, it was the state prosecutor that twisted into assumptions that Mr. Holmes was responsible for said crimes. It was the state prosecutor who pointed Mr. Holmes out prior to the trial and instructed me to identify Mr. Holmes as the "shooter," despite the fact that I told both the investigator and the state prosecutor that he was not the shooter. I attempted to mention this at the trial but I was instructed to only answer the questions.

Contrary to the state's contentions, it was not Mr. Holmes who was responsible for committing the crime(s) in this case. In fact, when I did the photo I.D., when I pointed out Mr. Holmes, I specifically indicated that Mr. Holmes was not the gunman, but rather, was involved in "the brawl."

Furthermore, I attempted to make contact with Mr. Holmes' Attorney, Richard Watts, and his office advised me that they were not permitted to have discussions with the victim or adverse witnesses in a pending case. Likewise, when I tried to speak to the state prosecutor to communicate my disapproval for causing my testimony to portray a form of perjurous critic, I was advised by them that the trial testimony had been taken and concluded.

Being appalled by the state's actions in moving to convict a person they knew was actually innocent, I sought to find someone who knew Mr. Holmes' family so I could do what I could to right this grotesque wrong, but was unable to do so.

In August 2010, while at a football game, Pop Warner, I noticed a young man with the same name as Sharrod Holmes, being a Junior. It turned out he was Mr. Holmes' son. I gave him my name and contact information and told him on my own free course, to please give my information to a responsible adult. I was later contacted by Mrs. Holmes.

I have willingly submitted this affidavit, in which I am willing to testify before a court of law.

SWORN AFFIDAVIT

I, Jarred Briscoe hereby make the following statement on my own free will:

On March 11, 2005, I was at Duke's bar in St. Petersburg, Florida. After being there for a while with my friends, I observed Sharrod Holmes along with several of his friends and companions engage in a fight with several other patrons of the bar. Sharrod and his companions were involved in a brawl which included beer bottles, pool cues, pool sticks, etc. At one point, I distinctly recall observing Sharrod Holmes pinned down towards the rear of the bar, not long after I witnessed another black male with an athletic build pick up a firearm from the floor. This caused wide spread panic and screaming, "He has a gun, he has a gun!" was yelled out about three or four times. As this individual pointed the firearm at Mr. Jenkins, he attempted to pull the trigger, however the gun apparently jammed and would not fire, as they both ran for the exit, then to the parking lot.

As people were making their way to the nearest exit and out of the door, shots were fired. As I ducked and ran to my vehicle, I witnessed Mr. Holmes and a few others run to the right of the parking lot, when in fact the shooting occurred to the left of the parking lot, around the corner of the clus which was located in front of the Howard Johnson Hotel.

I can positively state that Sharrod Holmes could in no possible way be the gunman because Mr. Holmes was not in possession of a firearm nor did he participate in the shooting event. From the beginning of the incident to the conclusion of the incident, Sharrod Holmes was in my eye sight the entire time.

I was never spoken to by law enforcement, any attorneys from either the state of the defense, nor anyone else who may have been involved in this matter.

I did not personally come forward with this information during the time of the initial investigation stages because I thought I had a warrant and I was avoiding contact with Law enforcement.

I recently learned that Sharrod Holmes had been arrested and convicted for this shooting through a mutual friend. Knowing that Sharrod Holmes is innocent, I provided this affidavit.
