ART CAMPS

Art Camps give children the opportunity to explore and experience a wide range of creative art projects. We expose students to a variety of art media, some of which may include: clay, collage, drawing, mixed media, painting, and photography. Our class size is small so all students get the attention they deserve (maximum 8 students for grades K-1 and 10 students for all other grades). Art Camps are taught by professional artists, professional teachers, and/or college art students, with volunteers and staff on site.
