2 Trials each day - 2 days - Saturday and Sunday October 4-5, 2025

These shows will be held inside, outside and outside under cover. There will be crating available inside on Saturday after Trial 1 Handler Discrimination and all day Sunday.

Location: Sheridan County Fairgrounds

Actual address is 1753 Victoria Street, Sheridan WY 82801 but you can get to it from 5th Street (Hwy 336/330)

From I-90 take Exit 23 head Westbound on East 5th Street (HWY 336/330) 2.2 miles-turn left into Fairgrounds

From North Main Street head West on West 5th Street (Hwy330) 1.3 miles-turn left into Fairgrounds

Pre-Entry open date September 2, 2025, and close date September 30, 2025

Entries will be limited to 75 entries per trial.

Saturday: Trial 1 - Handler Discrimination Novice and Advanced only and Individual Element – Exteriors Novice-Elite.

Trial 2 - Individual Element - Exteriors Novice-Elite

Sunday: Trial 1 and 2 - Individual Element – Vehicles Novice-Elite

October 4: T1 & T2 **Mary Lehman** (CO) Check in and Day of Trial Entries for TI and T2 – 7:45-8:15am and for 30 minutes after the conclusion of Trial 1 if space allows. General briefing at 8:15am. **Trial 1 will start at 8:30am with Handler Discrimination then Exteriors**; Trial 2 to follow T1 **with Exteriors** at the event committee's discretion after the 30-minute break.

October 5: T1 & T2 **Mary Lehman** (CO) Check in and Day of Trial Entries for TI and T2 – 7:45-8:15am and for 30 minutes after the conclusion of Trial 1 if space allows. General briefing at 8:15am. **Trial 1 will start at 8:30am with Vehicle Element**; Trial 2 to follow T1 at the event committee's discretion after the 30-minute break.

Entry Fees: **Pre-Entries**: Individual Elements \$20.00 and Jr. Handler \$10.00 per dog per run. Pre-entry must be received by September 30, 2025. **Day of Show entries**: Individual Elements - \$25.00 and Jr. Handler \$12.00 per dog per run. **Refunds** offered for injured or sick dogs, or





bitches in heat. If your entry fees were paid with PayPal and qualify for a refund you will be refunded the amount paid minus PayPal fees.

Entry Eligibility: To be eligible to compete in licensed Nosework event, dogs must be 6 months of age by day of event and permanently registered with UKC, have a valid Temporary Listing (TL) number or Performance Listing (PL) number as of the day of entry. An unentered dog may not be substituted for an entered dog.

Submitting Entries: Entries must be submitted on the current official UKC Nosework Entry Form. The new UKC Nosework Entry form is available at https://www.ukcdogs.com/docs/showforms/nosework-entry.pdf. Downloaded copies or photocopies of these forms may be used as well. The Secretary will send an email with a prefilled entry form before the trial opens if your dog has been entered in our trials before. Incomplete entries will not be accepted. Mailed entries must include the entire form and be signed. Mailed entries received without fees shall not be accepted. Make Checks payable to Rocky Mountain Dog Stars. A \$50.00 returned check fee will apply to checks returned for insufficient funds. PayPal payment is also available on the Rocky Mountain Dog Stars website by clicking on the Trial Payment page. If you pay with PayPal please note what you are paying for in the "add special instructions to the seller" field within PayPal and e-mail your signed entry form(s) to bkbasenji@hotmail.com.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
