Saturday, May 18, 2024

From I 90, take Exit 23 and head west on WY-330 W/WY-336 W/E 5th St. Turn left onto N. Sheridan Ave. Turn Right onto East Brundage Street. Destination is on the corner.

Pre-Entry opens April 12, 2024 and closes May 13, 2024

Saturday: Individual Element – Interiors - Novice though Elite **Sunday:** Handler Discrimination – **Novice and Advanced only**, followed by Containers - Novice through Elite

May 18: T1 & T2 **Tracy Patton** (CO) Check in and Day of Trial Entries for T1 and T2 - 7:45-8:15 am and for 30 minutes after the conclusion of Trial 1 if space allows. Trial 1 will start at 8:30 am with **Interior** Element; Trial 2 to follow T1 at the event committee's discretion after the 30 minute break.

May 19: T1 & T2 **Tracy Patton** (CO) Check in and Day of Trial Entries for T1 and T2 - 7:45-8:15 am and for 30 minutes after the conclusion of Trial 1 if space allows. Trial 1 will start at 8:30 am with **Handler Discrimination** – (Novice and Advanced) followed by the **Container** Element; Trial 2 to follow T1 at the event committee's discretion after the 30 minute break.



Pre-Entry Fees: Individual Elements \$20.00. Junior Handlers \$10.00. Pre-entry must be received by May 13, 2024

Day of Show Entry Fees: Individual Elements \$25.00. Junior Handlers \$12.00

Refunds offered for injured or sick dogs, or bitches in heat. If your entry fees were paid with PayPal and qualify for a refund, you will be refunded minus PayPal fees.

Entry Eligibility: All dogs must be permanently registered with UKC (Permanent Registration Number, Performance Listing, or Limited Privilege number) or have a Temporary listing (TL) number in order to enter. Dogs must be 6 months of age by the day of the event. An unentered dog may not be substituted for an entered dog.

Submitting Entries: A prefilled entry blank will be emailed out to previous exhibitors from our trials around April 5th. No entries accepted before April 12. Also, entries can be submitted on the current official UKC Nosework Entry Form. The new UKC Nosework Entry form is available at www.ukcdogs.com/Web.nsf/WebPages/DogEvents/Forms. Downloaded copies or photocopies of these forms may be used as well. Incomplete entries will not be accepted. Mailed entries must include the entire form and be signed. Mailed entries received without fees shall not be accepted. **Make Checks payable to Rocky Mountain Dog Stars.** A \$50.00 returned check fee will apply to checks returned for insufficient funds. **PayPal payment is also available** on the Rocky Mountain Dog Stars website by clicking on the Trial Payment page.
