Thank you for your interest in the 2nd Annual West Coast Multicultural Carnival & Festival on August 18, 2018 at Qualcomm Stadium in San Diego, California. Please read the following terms and conditions carefully before submitting application and payment.

Early Bird: Completed application with payment by April 16th 2018 will be considered early bird registration and you will receive a 15% discount equaling a savings of \$67.50 (Food Stand) or \$97.50 (Food Truck)

Deadline

A signed copy of this application must be completed and received no later than Friday, June 29, 2018. Upon receipt of approval by email, Food Vendors must apply for a Temporary Food Facility Permit (TFF) at least 30 days BEFORE the event (Thursday, July 12, 2018). Failure to do so will result in a late fee when applying for a Temporary Food Facility Permit. Payment Policy

Payment for vendor booth fee can be made by credit/debit card or money order. Refundable deposits must be made by check payable to San Diego Caribbean Association, Inc. A \$45.00 fee will be charged for all bounced/returned checks.

Refund Policy Vendor booth fees are nonrefundable as all funds are committed to the production, promotion, marketing and advertising of the Carnival.

Registration Process and Fees

To apply for the Carnival, please complete the application form attached to this document and return it by email info@sdca-inc.org as soon as possible, but no later than Friday, June 29, 2018. Within 24-48 hours upon receipt of your completed application, you will receive an email from San Diego Caribbean Association forwarding an invoice and confirming that you have been accepted. Immediate receipt of payment in full will complete your registration and ensure your space at the Carnival. For marketing purposes, free promotional flyers will be available at local distribution centers prior to the event. Your Carnival packet which will include four vendor passes will be available no later than Saturday July 14, 2018.

We will provide you with your space only at the Carnival. It is the responsibility of the vendor to provide any signage for their booth, tent, and all necessary tables and chairs, lights, and power extension cords as the Carnival will go into the evening.

Setup/ Break down

Setup will be on Friday August 10th from 4pm-8pm and Saturday August 11th from 7am-9:30am all vehicles must be off Carnival grounds no later than 9:30am. Breakdown and cleanup must be completed by August 12th 12:30am.

A refundable cleaning deposit of \$100.00 will also be due upon approval of your Vendor Application.

Insurance

We strongly encourage all event participants to carry insurance. Insurance must be obtained at vendor's own expense. San Diego Caribbean Association, Inc. where the Carnival is produced, assume no risk. By your participation in the Carnival and signing this application, the Vendor expressly releases San Diego Caribbean Association, Inc., and the City of San Diego City and San Diego County from any and all liability for any damages, injury, theft, or loss to any person or goods which may arise from the occupation of space by the vendor. Please provide a Certificate of Insurance adding the San Diego Caribbean Association, Inc. as an insured. Certificates of Insurance can be obtained for free with your insurance company. Sales Tax/Resale Number

All vendors are responsible for collecting and paying their California Sales Tax on all sales made during the Carnival.

A seller's permit allows you to collect sales tax from customers and report those amounts to the state on a regular reporting period (either monthly, quarterly, or annual). There is no charge for a seller's permit. If needed, you can apply for a Seller's Permit or for a Temporary Seller's Permit (limited to 90 days only) online by visiting at <https://boe.ca.gov/onlineservices/>.
