



Puppy Contract: Seller agrees to the best of their knowledge that the puppy is of good health upon leaving the seller's home. Seller agrees puppy will have begun vaccines prior to leaving. However, this does not mean that the puppy is immune upon leaving the seller's home. The puppy must be cared for in the same manner as if it is not vaccinated as it takes up to 19 weeks of age and multiple rounds of vaccines, which the buyer must provide, for a puppy to be considered immune. Only after the buyer completes the puppy's full set of required vaccines can the puppy be taken in public. Puppy should NOT be taken to public places until two weeks after the final round of puppy vaccines. The seller will supply the buyer with any vaccine records and any paperwork discussed. Purchase Agreement: A deposit in the amount of \$500 was received on _____ to receive a French Bulldog puppy. The remaining balance of \$3000 will be due via Zelle, venmo, or cash, on the day of pick-up, or the day before transport if the puppy is being shipped. Buyer and seller must agree on a pick-up date. The deposit is nonrefundable unless something should happen to the puppy before pick-up. If this is the case, the deposit will be refunded to the buyer. If the buyer backs out of the sale, the buyer forfeits the deposit given to reserve the puppy. If the buyer does not pick the puppy up on the agreed pick-up date, the buyer will be given one courtesy day. If the puppy is not picked up by the next day, the seller will place the puppy back up for sale the buyer forfeits the deposit and the contract is voided. If the buyer for any reason can't keep the puppy after purchase, the puppy buyer needs to return the puppy to the seller. The buyer will forfeit the purchase price.

Registration. (1) The seller guarantees this animal to be registered or qualified for registration with the American Kennel Club +Health of the French Bulldog puppy. (1) The seller agrees to deliver to the buyer a French Bulldog puppy with no symptoms of infectious or contagious disease

Health conditions (1) This guarantee does not apply to afflictions that are considered to be common in bulldog breeds. These include but are not limited to, cherry eye, entropion, "loose" hips, skin allergies, elongated soft palate, and collapsed nostrils. (2) Any kind of parasites, bacteria, viruses, and illnesses that could be associated with the afflictions listed in the section. 7.1 of this contract or environmental factors will not be covered by this guarantee. Including allergies, dysfunction, demodectic mange, and other autoimmune disorders. (3) The seller does not assume responsibility for any reaction to any vaccination. (4) The seller does not assume responsibility for any medical expenses incurred associated with any health problem. (5) This guarantee does not apply to any

physical problems which could be the result of an injury. (6) This guarantee does not apply to the presence of deafness or any kind of hearing problems.

+Puppy is guaranteed until its first birthday against any fatal genetic or congenital defects. The puppy must be properly cared for by the buyer and vaccines kept up to date. A veterinarian statement from a licensed and certified vet must be presented and the seller's veterinarian must verify the claim. The seller is not responsible for any vet bills incurred.

+Buyer must bring the puppy to a vet of their choice within 72 hours of purchase for a puppy wellness check. If the buyer does not do so, the health guarantee will be null and void. If the vet finds any fatal defects or deadly viral illness upon puppy well-check exam, the buyer must notify the seller immediately to return the puppy for a replacement puppy from the next litter. This does not include internal parasites or microorganisms.

+The Seller is not responsible for any vet bills, travel expenses, or any other purchases or bills accumulated by this puppy.

Puppy care (1) The buyer agrees to provide the puppy with routine preventative care and follow a veterinarian's guidelines for vaccination and deworming. (2) The buyer agrees to keep the puppy away from dog parks, grassy areas, pet stores, etc. until the puppy is at least 16 weeks of age and has received the final vaccination. (3) The buyer agrees to keep the puppy away from lakes, rivers, oceans, and other water with the puppy where the puppy can be in danger of drowning unless proper safety protocol is followed. (4) The buyer agrees to provide adequate fresh water, quality food and rest to the puppy. (5) The buyer assumes responsibility for protecting the puppy from loss, theft, danger, neglect, and abuse.

Return policy. (1) A puppy eligible for replacement, pursuant to section 6 of this contract must be returned or euthanized with prior permission from the seller to qualify for replacement. (2) The returned puppy must appear in good condition to the seller, other than the specified problem. (3) A puppy will not be eligible for replacement if it has been or appears to have been neglected, abused, bred, or euthanized without prior permission from the seller. The buyer agrees to assume financial responsibility for all transportation costs incurred for transporting the returned puppy to the seller. No refunds are given unless stated qualified health problems present themselves. If you decide you no longer want the puppy for anything other than health-related reasons I will take the puppy back and you will be offered a replacement but **no refunds** will be given.

Dispute. (1) This is the entire purchase contract; no other promise or stipulations are included or implied in this sale. (2) In any and all legal action pertaining to this dog, this contract shall be considered to be legally binding. (3) In the event of any dispute or disagreement under this contract, the laws of California will govern the resolution of the dispute, and venue for resolution of any dispute will be California. (4) To the extent that any provision of this contract may be invalid under any law of the state of the buyer, all remaining provisions remain binding.
