By turning a problem into an opportunity next to Ghanaian leaders we will reshape the country for generations to come bringing prosperity, employment, and opportunity

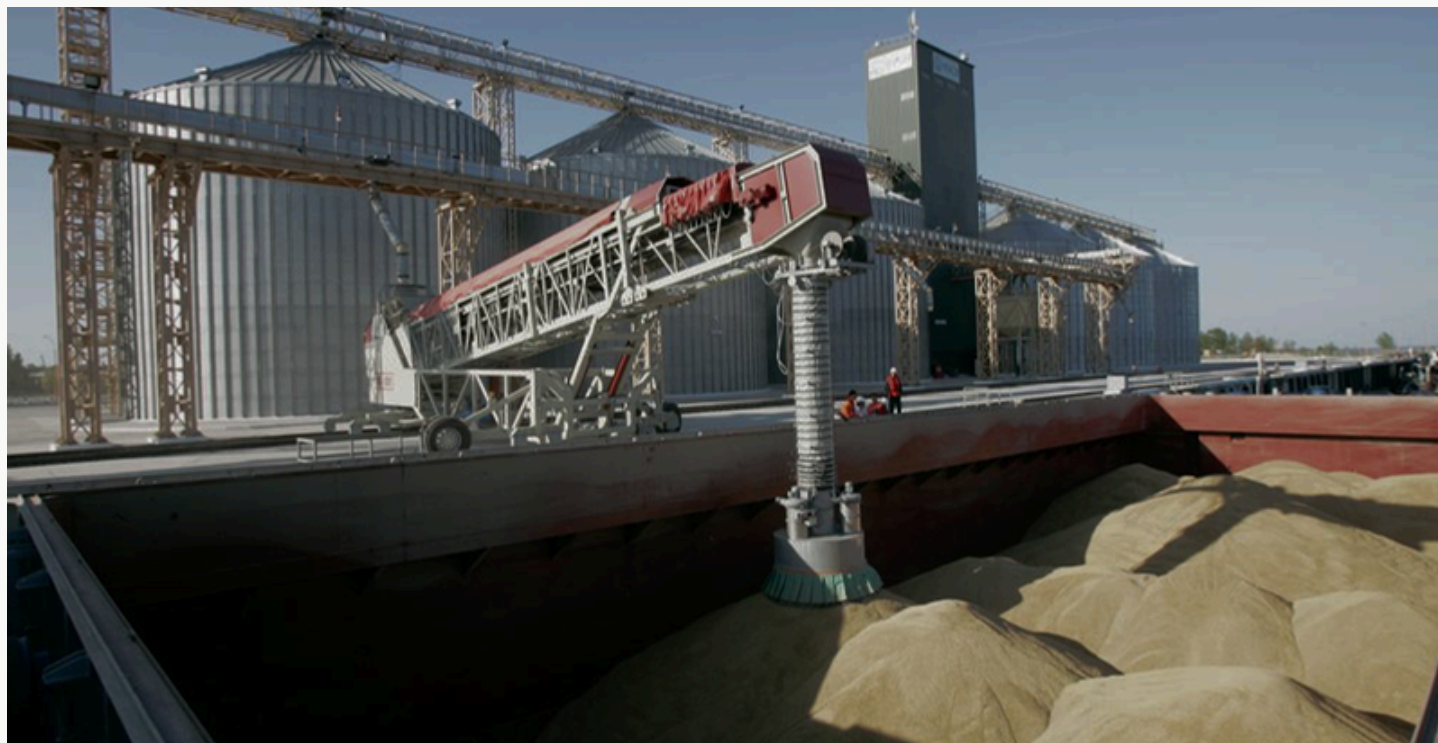

In order to participate, the Land Owner must control the land in accordance with **BOTH** the culture of their kingdom and the laws of the country.

When both systems are respected, the land has the equity value in the lease entered for **Majestic Farms**, to provide financing to the operator of the farm to grow the agriculture produce that generates the profit.

We do not seek land ownership, but, we require the security of a valid Twenty Five (25) year lease.

When a land owner is a capable farmer who is maximizing the lands potential and is successfully farming at an economic level it is best that they continue farming and **Majestic Farms** provides the necessary money to stabilize and grow operations.

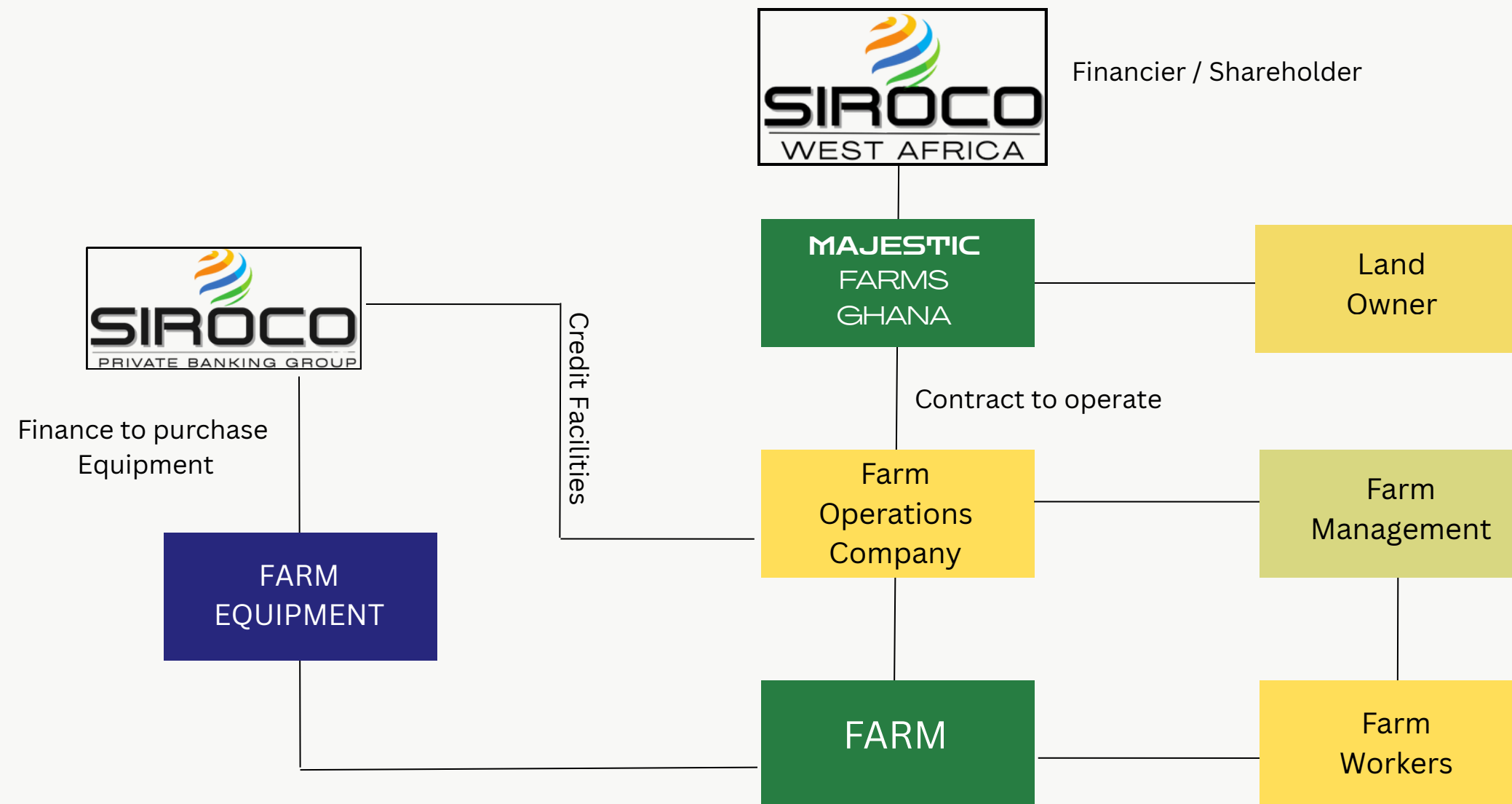
If a land owner needs to increase the productive capacity of their land they need to enter a partnership with a capable farmer.

There are many capable farmers in West Africa and **Majestic Farms** wants to work with them.

Majestic Farms may also be used as the farmer and offer economies of scale and ability having recruited good managers from within West Africa and beyond to realize the lands potential and profit.

The decision between the land owner and the **Majestic Farms** is part of the lease arrangement and decided by mutual agreement.





- Different Farms can have different Farm Operators Companies and different Farm Management.
- In an Ideal World, the Agriculture Department of the region of Ghana would manage with a profit share which would generate capital for use in the community.
- The Land Owner would be paid a fair yearly rental for the land.
- Farm Equipment owned by a separate company and rented to farms as needed in order to reduce capital costs and maximize profit to each farm.
- Profits generated will be used to assist in the collateralization of funds for schools, communities and hospitals.
- Majestic, the Mega development can be used to collateralize the farms and other community improvements.

STRUCTURE:

Our philosophy is to be actively involved in the future of those who work for and with us via direct company assistance and our J.V.Sparrow Community Assistance – Building Better Tomorrow's.

PUBLIC LISTING:

Majestic Farms, at the appropriate time, will list as a public company on the Stock exchange.

This will give protection to asset value for both **Workers and Management** while providing accounting and disclosure practices which assist the Land Owner in monitoring their partnership for production on their land.

LEASE AGREEMENT

Majestic Farms will lease land for 25 to 99 year terms depending on the land owners preference and undertake to utilize land management techniques that preserve the land value and improve its value and production over time.

Although arrangements will vary between land owners, the responsibility of respecting the lands cultural importance is understood and will be respected.

- 4 Sales underwritten for farmers and performance guaranteed for clients.
- 5 Long term financing for medical, social and community infrastructure arranged.
- 6 Equipment leasing.

INTERNATIONAL CREDIT FACILITIES

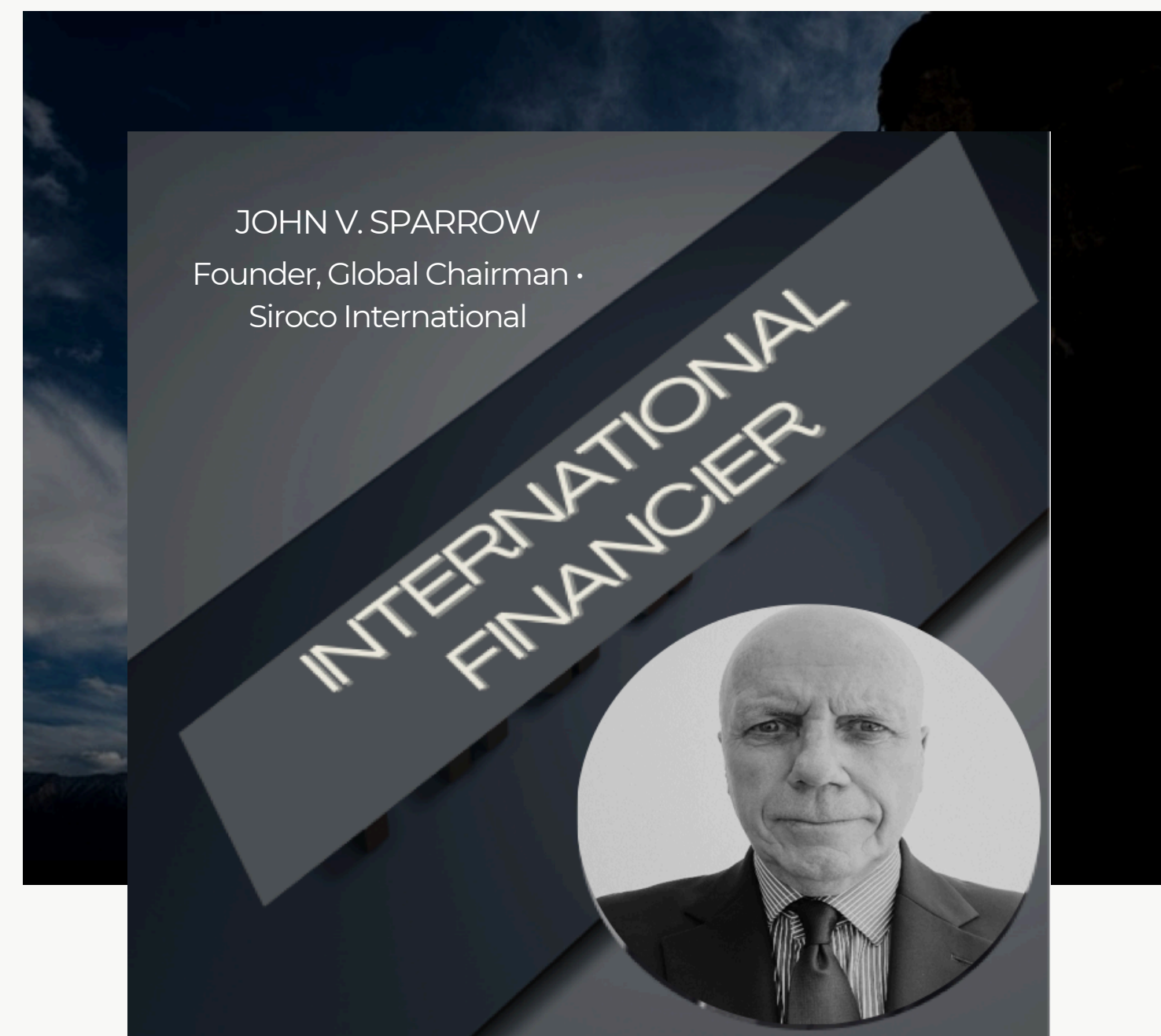
