#### **Financial Report:**

## **Property Status Discussion:**

Need to reschedule meeting with Pro-Vigil to discuss cameras.

East and West fire gates have passed inspection.

Concerns about the porter being able to fulfill the porter duties. If he gets injured, he could file a workers compensation claim. Since we let him set his own schedule, could he be considered a contractor?

We are reviewing quotes and coverage for flood policies. We would prefer to have one agent for all coverage.

Unit 311 foundation floor cracks, waiting on estimate from Jorge.

Building 3/Unit 311 drainage improvement estimate from Jorge is \$3100 - \$3500.

Building 3 sidewalk and stairwell estimate from KJ is \$2900, Jorge's estimate was \$4600. Randall will work with Jorge on scaling down work to be done.

Unit 206 blinds and one window are broken on enclosed patio (sunroom).

KJ estimates a cost of \$100 to inspect each unit for leaks and other issues.

KJ bid for HVAC in office \$4700 (\$3400 for a mini split system).

Unit 1608 needs front door painted.

Unit 1208 front door needs to be cleaned.

Billie will work with Diffee on fall color.

Per the Dallas Fire Department, the only grills allowed on patios are electric grills.
