Flood policies for buildings 9-12 were renewed.

Illegal Dumping Reminder emailed to owners.

The last satellite dish at the complex was removed from building 1.

## **Property Inspection:**

The property was inspected between November 10 and 18 and a list of violations observed was produced. The list was sent to all board members to review offline. The board will be asked to approve or modify the violations list. After board approval, AMGI will send owners Violation Warning Notices.

#### **Fall/Winter Preparations:**

Faucet Covers will be placed on water spigot valves by the end of November.

Most pool area furniture will be put in storage by the end of November.

Freeze notices and tips to help prevent freezing pipes will be sent again as each hard freeze is forecasted.

Board voted unanimously to send a communication to owners with exterior laundry rooms requiring that they sign a certification letter that the built-in heaters in their external laundry rooms are operating properly. Owners will have 30 days to sign and return the certification letter or start receiving fines for each month it is outstanding.
