Re Your Legal Duties to Disclose Information

You failed to comply with your duty to account honestly to Parliament yesterday when you were present at the meeting of the House of Commons' Liaison Committee.

You should immediately make arrangements with the Speaker of the House of Commons and the Leader of the House for you to go to the Commons and, before it rises for the Summer Recess, make a personal statement to inform Parliament as follows:

1. That you accepted **three times** – on 27 February 2025; 2 April 2025; and 21 July 2025 – that as a matter of fact and law your reputation includes you being a “*fraudster*” and that you have acted criminally in purporting to be a lawfully elected Member of Parliament and the legitimately appointed Prime Minister of the United Kingdom; doing so in breach of your overarching duty as a Privy Counsellor to comply with the law as set out in section IV of the Act of Settlement 1700.
2. That all the international agreements, treaties, accords, protocols, declarations, consents etc that you have signed or agreed to as the UK's Head of Government were/are Null (ie *void ab initio*) and that the United Kingdom is not bound by any of their terms. No agreement with Spain over Gibraltar can be entered into by any Minister of the Crown.
3. That your accepted legal status threatens the Defence of the Realm as you cannot give a lawful Directive/Order (spoken or written) to the Chief of the Defence Staff (or any other person) for UK Armed Forces to “go to war” or to carry out any armed activity in another country. In respect of Article 2 (as read by Article 17) you are acting unlawfully as set out in section 6 of the Human Rights Act 1998.
4. That you have informed His Majesty the King that you have resigned as Leader of the Labour Party and have accepted appointment as Crown Steward and Bailiff of the Manor of Northstead and will therefore be vacating 10 and 11 Downing Street, Chequers, and your offices in the House of Commons by no later than 26 July 2025.

As Prime Minister *de facto* – not *de jure* – you cannot carry out a reshuffle of the Cabinet and sack any Minister who was appointed by His Majesty the King and whose appointment was confirmed by Letters Patent. Nor can you make any alteration to an existing Department of State or establish a new Government Department (such as a Department of the Prime Minister). You cannot “advise” the King.

I suggest that you should immediately inform the Chair of the Labour Party, Ellie Reeves, so she can inform Members of the Cabinet and the Chair of the PLP about what you are doing.
