Judicial Review Proceedings

Further to my letter of 1 February 2025 (which was in your possession/control on the 5th) I am sending you relevant information concerning various other failures to respect the Rule of Law; my related engaged Convention rights coming within the scope of Articles 9 and 10; my duties as a United Nations and Council of Europe Human Rights Defender; and the public interest. Please see the five Appendices to this letter.

Appendix A relates to the fact that on Friday, 7 February 2025 Sir Keir Starmer acted in breach of section 3 of the Fraud Act 2006 with yourself and other members of the Cabinet (and other Ministers of Crown who were present at the extended Cabinet meeting at Lancaster House). The honest disclosures of information which he should have made in accordance with his legal duties include the following: (A) That he acted in breach of sections 2 & 3 of the Fraud Act with (amongst others) the persons who nominated and seconded him (plus the Subscribers) to be the Labour Party candidate for the Constituency of Holborn and St. Pancras on 4 July 2024. (B) That he acted illegally under section 7 of the Fraud Act when he signed the related Consent Form in order to be deemed an election candidate in the General Election. (C) That he acted in breach of section 2 of the Fraud Act with the Acting Returning Officer for the Holborn and St. Pancras Constituency; Camden Council; the members of Holborn and St. Pancras Constituency Labour Party; Royal Mail Group Ltd; ITV, BBC and Sky TV; the Metropolitan Police; and others. (D) That he acted in breach of sections 2, 3 & 4 of the Fraud Act with the persons present/represented at the Labour Party's "Clause V" meeting on 7 June 2024 and the members of the [then] Shadow Cabinet present at the launch of the Labour Party's General Election Manifesto on 13 June 2024. (E) That prior to 4 July 2024 he had acted in breach of section 3 of the Fraud Act with Sue Gray (now the Baroness Gray of Tottenham) and with Rebekah Brooks (Chief Executive Officer of News UK). (F) That on 5 July 2024 he acted in breach of sections 2, 3 & 4 of the Fraud Act with His Majesty the King. (G) That he acted in breach of section 3 of the Fraud Act with persons who were appointed by the King as Ministers of the Crown subsequent to 5 July 2024. (H) That the Salisbury Doctrine does not apply to any Government Bill, and that the Finance Bill cannot be passed and lawfully receive Royal Assent. (I) That he had acted illegally over Rwanda and in bad faith with President Paul Kagami; (J) That he had acted illegally over the appointment of Lord Mandelson as the UK Ambassador to the United States; (K) That he acted illegally over the appointment of Lord Evans as Chair of the Crown Nominations Commission for Canterbury. (L) That he has acted and is acting illegally over the proposed international treaty between the United Kingdom and Mauritius.

Appendix B relates to: (A) the acts, omissions and failures to act of the Archbishop of York, and the former Archbishop of Canterbury in relation to a number of Clerks in Holy Orders who had acted in repudiatory breach of their legal duty regarding the Mission of the Church of England and their related responsibility for the cure of souls. (B) The requirement for the Archbishop of York, in his legal capacity as a Privy Counsellor, to inform His Majesty the King that Sir Keir Starmer has acted and is acting in breach of sections 3 & 4 of the Fraud Act 2006 in respect of matters concerning the Defence of the Realm and a British Overseas Territory; UK Foreign Policy; and relations with the Commonwealth and the Commonwealth Realms.

<u>Appendix C</u> relates to the legal problems that affect the legitimacy of the Crown Nominations Commission for Canterbury; the impossibility for the Commission to make a lawful nomination for His Majesty as Supreme Governor of the Church of England to appoint a person as Archbishop of Canterbury; and the related legal problems which will arise throughout the Anglican Communion.

The above issues have a bearing on the position of His Majesty's Government and the case of Gaie Delap. Would you please ensure that copies of the documents I sent in May last year to/for the Lord Chancellor and my letter of 9 September 2022 to the Clerk of the Crown in Chancery are provided, as a matter of urgency, to: Sir Keir Starmer; Rishi Sunak; the Archbishop of York; the Solicitor acting for Ms Delap; Justin Welby, and myself. They relate to questions of law of general public importance and great constitutional significance which will necessitate a Judgment of the Supreme Court (please see <u>Appendix D</u>, which is page 6 of my Written Submission of 26 May 2024).

Please note that if by the end of the Court day on 27 February 2025 Sir Keir Starmer has not personally issued a Claim in the High Court of Justice for Defamation due to me writing and publishing that *he has acted criminally* and that *he is a fraudster* he will be expected to tender his resignation to HM the King the very next day and be appointed as Crown Steward and Bailiff to the Chiltern Hundreds. At the end of all civil law proceedings Sir Keir Starmer is to be reported to the Serious Fraud Office for his various criminal offences. I refer you to <u>Appendix E</u>. (<u>NB</u>: The term "nomination form" on the second line of the letter's penultimate paragraph should have been/be "consent form".)

In dealing with the various matters I have raised and raise, please ensure that my rights as a disabled person with a severe disability (whose protected characteristics include age, religion, and belief, as well as disability) are taken fully into account and that Ministers and Civil Servants comply with their legal duties under section 149 of the Equality Act 2010 and section 6 of the Human Rights Act 1998.
