## GFWC Glendale Woman's Club 2024 Reverse Draw Raffle Rules

By purchasing a Ticket to the 11/15/25 Reverse Raffle Drawing (RRD), the purchaser agrees to comply with the following terms;

- 1. The purchase price of one reverse raffle ticket is \$25.00. All online purchases must be made prior to 11-12-2025. We accept cash, check or online payment using Zelle, Venmo or Cashapp using cell phone number 623-937-9915. If a check is not honored by the bank, we will attempt to resolve by contacting the purchaser by telephone or email. If we are unable to clear the payment by 12 noon on 11-14-2025, that raffle ticket will be declared invalid.
- 2. This raffle drawing will be limited to 150 tickets and sold as first paid, first served. If 150 tickets are not sold by 12:00 pm the day prior to the drawing, the reverse draw raffle will proceed but the prize structure will convert to the *same* % of winnings based on number of entrants.
- 3. The grand prize winner will be determined by a random reverse draw raffle taking place on November 15, 2025. The reverse raffle drawings will be live streamed via Facebook <a href="https://www.facebook.com/GlendaleWomansClub">https://www.facebook.com/GlendaleWomansClub</a> At 12 noon the first 50 numbers will be eliminated.
