

**Gold Coast MARC Membership Meeting Minutes**

1. Pledge of Allegiance
2. Treasurer's report: \$3,180.62 per Trish Davis
3. Membership report: 70 members per Tony Spaich. Effective immediately Tony Spaich resigned from the Board for personal reasons although he will continue performing membership functions for the club. The membership voted to present Tony with a plaque commemorating his 35 years of service on the club's Board.

1. New members will receive welcoming email and PDF of roster from Dick Rust with a statement that the roster contains private information and it is not to be used for any commercial or solicitation purposes.
2. Tune Up & Tube Steaks event 4/23/22 was great success due to efforts by Jerry & Dorice Carbone. 18 Model A's and 40 participants.
3. Sweet Corn Fiesta event 4/24/22 at Palm Beach County Fairgrounds on Southern Boulevard. 16 Model A's. Event organizer wants us to participate next year. We would set up closer to event and security of our cars will be discussed prior to next year's event.
4. Club coffee mugs with our logo on both sides: By a vote of 18 for and 4 against the membership voted for the club to purchase 144 coffee mugs from 4Imprint at a cost of approximately \$3 each. Each paid member gets one at no charge; \$5 for each additional mug.

8. Paul Lapidus to investigate possible weekend overnight event with Palm Beach A's in October 2022 as was done several years ago.
9. Next year's (2023) Model A Judging Event: Possibly at Quiet Waters Park in Deerfield. Same venue and format as Tune Up & Tube Steaks event. Palm Beach A's (Dave Carlson) suggested a joint event at Ford's Garage Restaurant in Wellington in early March 2023 (10 of their cars would participate). Board felt that may present logistics issues with parking lot venue. Stuart Vogel discussed the Ford's Garage venue with the restaurant owner who assured him that they would welcome us at any time for any of our events. Dick Rust offered to research using the park at the west end of Atlantic Avenue in Delray.
