RELEASE AGREEMENT**

The undersigned, being fully aware of the risks and hazards inherent in participating in the Event, hereby elects voluntarily to engage in such activity and voluntarily assumes all risk of loss, damage, or injury, including death that may be sustained by the undersigned, or any property of the undersigned, while engaged in such activity.

This release shall be binding upon the distributees, heirs, next of kin, personal representatives, executors and administrators of the undersigned.

The undersigned also acknowledges the fact that Sponsors may publish photographs of the Event to be used in connection with the promotion and advertising of the Town and similar future events, the undersigned hereby grants to Sponsors the right to use his/her likeness in photographs, or on film, or videotape in the above promotional and advertising materials and may be exhibited and re-exhibited without limitation to liability.

This release agreement shall extend to all claims, demands and causes of action whatsoever arising wholly or in part from any act or omission of the Sponsor, its officers, agents and employees or any one or more of them.

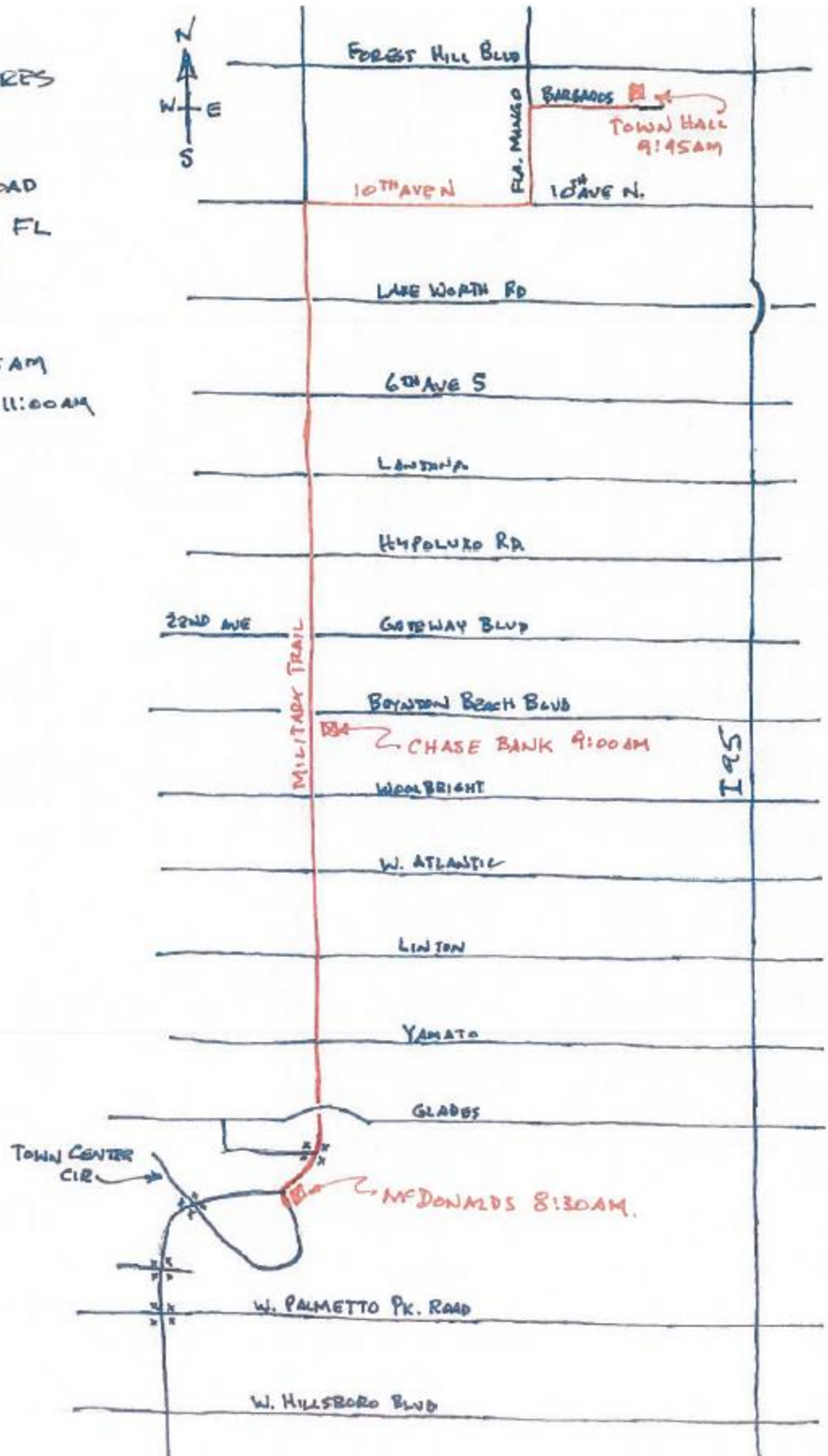

RULES FOR PARTICIPATION

- Placement:** The Town of Lake Clarke Shores reserves the sole right to place parade participants in any order deemed appropriate. Placement is not on a first-come, first-served basis. Entries will receive their parade order numbers prior to the day of the event if pre-registered. If participant registers the day of, number will be assigned then. **PLEASE NOTE:** *If registration is done last minute, the number assigned will be towards the end of parade.* Initials _____
- Solicitations:** Solicitation of funds or selling of merchandise during the parade is not permitted. **Political advertising/ solicitation is PROHIBITED.** Initials: _____
- Restricted Objects:** None of the following items may be handed out or be part of your contingent without the prior written approval of Parade Producers. **Political Signs – zero tolerance**, live animals, bottled water, confetti, silly string, air horns, or amplified sound. Furthermore, the Town of Lake Clarke Shores prohibits the following items along the parade route: glass bottles, balloons filled with anything other than helium or air, body armor, bricks, stones, weapons, projectile launching equipment (including water guns) or operational gas masks. - Alcohol or Drug Use:** Alcohol and drug use are prohibited in the pre-parade assembly area or on the parade route. Initials _____
- Good Taste:** Nudity, lewdness, or obscenity is prohibited by state and local laws. All entries must exhibit good taste or be removed from the parade. Parade organizers shall have sole discretion to determine violations of this rule. Initials _____
- Behavior:** Courteous and respectful behavior is required at all times. Individuals or groups exhibiting abusive or inappropriate behavior towards parade organizers or others may be removed from the parade. Initials _____
