

REPAIR AND MAINTENANCE OF RAY VOIGT'S MODEL A FOUR DOOR SEDAN By Harold Feinberg

This past fall Tony Spaich and I discussed the possibility of doing the repairs on Ray's car so he could see it running one last time. Unfortunately we were not able to get things going in time. We spoke with Mary Voigt to see if she would like us to get it going in case she wanted to sell the car. She said that she would like to get it running again for their children.

Bill Locklin and Roberto Vichera offered their garage facilities for us to do the work. We decided on Roberto's since it was closer.



One morning I went over to Mary's to check the car to see if it could be driven to Roberto's. We spent most of the morning clearing out the garage to gain access to the car and hopefully be able to drive it out of the garage. Since there was no gas in the tank, I shot over to the gas station to buy some gas. Fortunately, Ray kept the battery on a trickle charger. I tried to start the car and had no luck. I inspected the carburetor and could see that it was all gummed up. I had brought an extra re-built carburetor with me. After changing the carburetor the car started right up. I checked the water and oil and took the car for a ride. Although it ran a little rough, I felt confident that I could make it to Roberto's for the workshop the following week.

George Phipps mentioned that one of the wheels did not look safe the last time he drove the car with Ray. I was able to find a matching wheel at a reasonable price at Bob Dobbins' garage.



June 2, Tony Spaich and I picked up the car, and, after stopping for some more gas, we proceeded to Roberto's with no problems. We were met with a great showing from the club. Roberto Vichera, Russ Gagliano, Dick Rust, George Phipps, Jerry Carbone, Trish and Alan Davis, Erich Gompertz and Bill Locklin (I hope I did not forget anyone).



Upon assessment, we realized that this was not going to be a simple task. It was determined that the radiator should be pulled and sent to a radiator shop.



We rebuilt and replaced the water pump, the distributor and the carburetor. We installed new spark plugs and reset the timing. We also replaced the wheel that was corroded. We made a list of parts that would be needed and I ordered them from Phane Jones who rushed them out to me so we would have everything for the next workshop.



During the following week, I met with the Davis' to prep and paint the front end and engine in preparation for the installation of the radiator. Russ Gagliano took the radiator to one of his vendors and had the radiator cleaned and repaired. Then Russ painted the radiator and delivered it to Roberto's garage for our June 9th workshop. While I was at Roberto's, we changed the oil and greased the car, and checked the air in the tires.

On Saturday, the 9th, we re-installed the repaired radiator and the motor meter which I was able to re-build. We started the car, and it ran beautifully. We did some other minor repairs but were unable to solve the electrical problem. We took out the alternator and replaced it with a spare generator that I brought. Still not charging, so we replaced the cutout with a new spare that I brought. Still not charging, so we replaced the ammeter with a new one that I had. Still not charging and we were getting frustrated. Dick Rust said he had a new re-built generator at home, so we decided to call it quits and we will be meeting at Roberto's Thursday the 14th for the final time (hopefully!!).



I feel confident that we will have Ray's "A" up and running this week. We could not have done this without all the expertise and elbow grease of our fellow members; I know Mary has expressed her appreciation to the Club each time she gets a progress report. It's nice to know that our Club members will rise to the occasion when a fellow member is in need.

The years went by, and he would not budge, and then I enlisted in the US Navy. Over the next two and a half years I was trained as an aviation electrician, flight crewman and rescue swimmer at the Navy school in Jax. Fla. After that I flew with a search and rescue crew out of Keflavic, Iceland, did a Mediteranean tour based in Naples, Italy and wrapped it up in Norfolk, VA.

Shortly after the Navy I met my future bride at a boat club that my parents belonged to. We fell in love, dated for years, and then Marlene and I were married. That was 44 years ago and it has been a wonderful ride since. My other love, besides Model A's, is bass fishing, which I have fished a tournament, once a month since 1975. I have been crowned "bass angler of the year" nine times. The walls in my den are lined with first place trophies. It is just something I love to do, and I still compete, winning Angler of the Year as recently as 2011. Not bad for a weekend fisherman, who holds down a full time job, plus raising a family.

But getting back to our Model A's. Upon my return home from the Navy, I learned that Mike had passed away, the garage was empty, and someone new was living in the home. I tried to find out what happened to the car, but could not get any information. Years later we bought a 1966 Mustang, and restored it to original condition. But I still remembered Mike's A. And then one day we stumbled across a Model A at Collectors Cars in Miami. It was a Hot rod with Mustang running

gear, A/C, auto and crushed red velvet interior. I fell in love again, worked out a deal and traded even for my mustang. We loved that car, had a great time with it. But then we fell on hard times when Eastern Air lines went out of business. I lost my job of twenty eight years and we had to sell the A.



Years later we reached that point in our lives where another Model A was overdue. I started searching the internet. We found a lot of cars that needed a lot of work, but after talking it over we decided to search for one already restored. We thought if we get a car already to go, all we had to do was start enjoying life again with a new "A".

We found 'Nellie', a 1929 Fordor, on E-bay, up for bid with a reserve. I had no idea what the reserve number was, and I was not into bidding, so we contacted the seller, Rusty, and we talked, and talked some more, and soon were talking daily. I decided to let the bid run out, and if the car was available after that, I would call him and try and come up with a deal we both could live with. I marked his car with a bid watch, and was kept informed via e-mail of the current bid. At the end. the reserve was not met, so the car was available. I called him on Monday morning and we began to talk again and before the day was out, I sent him a deposit on that car. I lost a lot of sleep that week. Here I was buying a car on someone's word whom I have never met, and a car I have never driven. Sometimes you just have to trust people in what they say, and I did, and I am really happy with the outcome. On top of that, we made a friend, and we have talked a couple times a week since.



Now that we made a deal for the car I had to figure out how to get her home. Rusty said he could trailer it to a half way point, and if I rented a trailer I could meet him, and we could swap the car for the balance of the money and I could drive back. Only trouble with that was, to get the time off work, rent a trailer, and pay for gas up and back, added up to a nice chunk of change. As an alternative I found a transport trucking company located in Miami, with a safe record and a good standing in town, checked the weather for the weekend, then gave them the okay.



How is that for luck! That motor is the original one that came with the car, and the numbers match the title. What a great thing to have with 'Nellie'.



Twenty three long years had gone by since we had to sell the red A. Finally on January 28th, 2012, 'Nellie' was delivered to our front door, and we started enjoying life to the fullest again. We've done a few shows with her, including the southernmost car in Key West and won a few trophies. She was originally titled in Nebraska, so the name "Nellie' seemed to fit. Now, every time I walk out to the garage and look at her, she makes me smile. What a great car 'Nellie' turned out to be. I have fallen in love all over again.
