Officers may succeed themselves.



TOURING-Proper way to Caravan

You are responsible for the car behind you. Look in the rear view mirror often, if he slows down or stops then you do the same. The driver in front of you does likewise. If you make a light and the car behind you doesn't, pull over and the car ahead will start a chain reaction. We HOPE they are paying attention and pull over also. If the caravan makes a turn, make sure the car behind you sees you. If he is lagging too far behind wait at the turn until he sees you, then proceed into the turn. This way there is less confusion and all will arrive at the same time and at the same location.

TECHNICAL TIP by Roger Kauffman

This month's tech tip is the result of many questions about the rubber liner used in the inside center of a Model A wheel. I get lots of questions about what it was, what does, is it necessary to replace it? etc. Originally, these rim liners were rubber strips hade from old scrap inner tubes, heavy waxed paper or lightweight waxed cardboard trips.

The intent was to keep the tube from chafing as it flexed on the inside of the wheel. Also, if the inner tube sticks to the center inside of the wheel, it will not scoot or slide as needed, and will stick from heat and tear as it is in travel. If the inside of the rim is a ttle rough (rust pits) the constant flexing and scooting over a rough surface will cause thin spot to develop in the tube eventually causing it to go flat.

I use 2 layers or rounds of duct tape (sticky side to the wheel) going completely round the center of the wheel. I also apply a very lightly dusting of talcum powder on ne tube and inside the tire. This also helps prevent rubbing or chafing of the tube. This /orks for me as last summer I ran over a roofing nail and got a flat tire.

When I removed the tube from the tire it was in like new condition, no rub or chafe narks. The tires and tubes had been mounted 12 years ago and had nearly 40,000 miles n them.

Tiny Tips From MAFCA Members

Installing Rubber Grommets or Rubber Windshield Frame Gasket Installing rubber gromments and tight rubber gaskets that must slide in a track can be a difficult task without something to help them slide into the right place. Use a little full strength liquid dish washing detergent directly on the rubber that needs to slide into position. The soap will help the rubber slide and not deteriorate the rubber like grease or other petroleum products.

When installing the gaskets in a windshield, allow the gasket to sit overnight before doing the final trimming and mitering of corners.

The pulling has stretched the rubber and if you cut to length right after installing, the contraction will yield a short gasket and you will not be happy with the fit.

We've all heard the famous words, "They can have any color they want, as long as it's black," attributed to Henry Ford in reference to the first Ford automobiles. When did other colors become available?

Many people think Ford's Model T was available only in black. In fact, it also was offered in blue, green and bright red from 1908 to 1914, when the moving assembly line was introduced. The new production process required a fast-drying paint, and only a particular black one suited the purpose. Thus began the "black, black or black" period, which lasted until 1925.
