From the Presidents Dash





How a ravine dumped Model T became Silvio Cote's National Champion As told to John Ford

It's really quite simple: take a pile of junk, get an expert machinist who's also a world class defense engineer, buy or make a bunch of new parts and voila, a restored Model T. Oh yeah, add 14 years of work.

To help get my '31 rear axles replaced, Silvio Cote loaned me his rear spring spreader a few days ago. While picking it up I saw his incredible 1915 Model T Coupelet. Knowing it would make a great story for the Blast, I started asking questions. In the process I got a second story about his incredible life.

It begins way up north in Quebec where Silvio was born. While still a young boy, his family moved to the middle of Alberta, Canada. There winter temperatures sometimes dropped to - 50 degrees. It was a hard place to live in the late 1920's. His father died when he was six and his mother passed away just as he graduated high school. To support himself and his three younger sisters, Silvio got a job at Northern Electric Co. where he received training to become a machinist, tool maker and then an engineer. By age 30, however, due to recurring pneumonia, he was given just two years to live, if he didn't move to a warmer climate. So he relocated to Ormond Beach, FL, where for the next ten years, he worked for defense contractors. In 1964 he moved to his current home in Ft. Lauderdale and quickly found work as a machinist & tool/die maker at more defense contractors. Among the many projects he worked during the next 26 years, he supervised the manufacturing of the world's top rated jet fighter chaff defense system. Later his knowledge of the chaff system took him around the U.S. and overseas to various naval stations and NATO bases where he trained their personnel on how to install, maintain and use his company's equipment. He retired in 1990. Silvio is now 88 years old, sharp as a tack (he saw my license tag had expired, unbeknownst to me) and says his secret to good health is to always be doing something, like overhauling our old engines or turning out metal parts in his home machine shop. So now that you know a little bit about Silvio, here's the story of his extremely rare 1915 Ford Coupelet and its restoration.

It begins just before WWII. Silvio's 1915 Model T Coupelet was rusting away down in the bottom of a ravine somewhere up in the northeastern states. It had been pushed down there many years ago. At the bottom, the T crashed into a tree which destroyed the front end. The local people knew about it, but had forgotten who dumped it there. Then in 1940, a milk route delivery man who knew about it decided he wanted to add the rusting wreck to his growing collection of old discarded cars. But first, a tree growing up through the middle of the body had to be cut out. It was then pulled up out of the ravine by cables tied to back of a truck. Thereafter, for the next 30 years, what was left of the old Coupelet sat in a barn with other wrecks. Finally, in 1970, while looking for rare cars with restoration potential, Silvio heard about it. So he contacted the milk man and was quoted \$1,500. But as is typical when buying Model A's, when he drove up north to see it, it was in much worse shape than the milk man's description. Plus now that Silvio had driven all the way up there, the guy raised the price \$100. What a rat! You might say Silvio was getting milked by the milk man. He almost walked away, but decided to bite the bullet and pay the The 55 year old wreck was put in an enclosed trailer and hauled down to Florida. Upon arrival Silvio had to unload it in front of his house. But first he looked up and down his street to make sure nobody was watching. He was afraid if neighbors saw what he had just bought, word would get around that he was crazy. Thus began its fourteen year restoration. (Continued in January)

The other project, 1928 Model AA truck, has been a completed rolling chassis awaiting the body/cab restoration. New wood, new body panels and a little additional wood work for the Stake Body, and that project will be completed by Christmas......2012.

Two projects being worked on at the same time, why not finish one and then the other you ask? No explanation that sounds normal......but who in the club is normal, loving and driving vehicles with no air conditioning, questionable brakes and a musical sound system that sounds like someone singing in the shower. But who can resist the fun.

The Ammeter!

The ammeter in a Model A Ford can be a very useful tool in a variety of situations that will signal to the driver the car's electrical status.

Whenever you park a Model A and are about to exit the car, glance at the ammeter, the needle should be pointing to zero. If instead it is pointing slightly to the left it is telling you that somewhere within the car there is some unauthorized current flowing that is going to drain the battery if you leave it that way long enough.

The cause may be the headlight or dome light switch is turned on. It is also possible the contacts in the generator cutout switch have stuck closed. Another possibility is the brake light switch is closed due to a weak spring in the switch. What ever is the cause you will become aware of it and can immediately address the problem instead of returning to find a dead battery.

When you first climb into the car to go for a drive before starting the engine press your foot on the brake pedal while observing the ammeter. The needle should deflect to the left. This is telling you that your brake light switch works and at least one of the bulbs is not burned out.

When you start the engine and rev it up past idle the ammeter should deflect some distance to the right. This is telling you the generator has taken over the car's electrical load and is also supplying charging current to the battery. If the needle stays at zero or deflects to the left it is telling you the generator is not working.

The ammeter can also be used as a gauge to set the generator output. This is accomplished by moving the third brush in the generator. Moving the brush changes the generator output voltage level and will determine the amount of charging current that flows to the battery. The procedure is to have the engine running at an rpm higher than idle with everything accept the ignition turned off. The generator is then adjusted for a nominal 8-amp output as registered on the right side of the ammeter.

Eight amps is considered nominal, but you can set it for whatever value suits your driving needs.

In 1929 Ford moved the black primary wire that runs to the ignition coil from the passenger side terminal of the junction box on the firewall to the driver's side terminal (reference service bulletin page 390, November 1929). The purpose of this change is to have the ignition current pass through the ammeter to provide a diagnostic tool when starting the engine. If for some reason the car refuses to start while cranking it over, observe the ammeter. The needle should be alternately moving from left to right past the zero mark. This is being caused by the ignition points opening and closing and it is telling you the ignition primary circuit is working correctly and the problem is elsewhere.

If you have replaced the generator with a modern alternator, which has a regulator, the ammeter will tell you a number of things. When you first start the car up and are rolling down the road the ammeter will more than likely be far to the right side of the zero mark. This is telling you the regulator in the alternator has determined that the battery needs significant charging to replace the power that was used by the starter to start the engine. After some period of time the needle will pull back to zero as the battery regains its full charge. If the needle remains far to the right for an excessive period of time it may be telling you that you may have a defect in the battery, such as a dead cell.

On a long trip the ammeter needle should be sitting on zero indicating that the battery is fully charged. However, it may also be an indication that the alternator is not working. An easy check is to momentarily turn the headlights on. If the alternator is working properly it will immediately pick up the additional load. You may see the ammeter needle flicker slightly, but it should remain on zero. This tells you the alternator is working. If the needle deflects to the right significantly and stays there it is telling you the alternator is not working and the battery has picked up the additional load.
